Here are some points to consider as you debate awarding an administrative contract to the Art Center for manhole artwork.

Why outsource to Art Center?

• Art Center has expertise and experience in public outreach. This outreach and the attendant competition may be as important as the artwork.

• Outsourcing design selection is a two year experiment in which staff will learn and the city will develop competencies in our creative sector for when resources like these are needed.

Why manhole covers?

• Fabricator will imprint unique design relatively cheaply.

• Builds community stakeholders for creatively designed infrastructure.

• Not new - Japan has taken this to a new level. <u>link</u>

Who is the audience for this artwork?

Family and extended family of design competitors.

• Mass media consumers who see photos of Ann Arbor's manhole covers representing a unique creative hotspot where residents design manhole covers.

• Pedestrians and bicyclist who encounter them in crosswalks, near schools, in sidewalks, etc.

Why put creative design in infrastructure?

Identifies Ann Arbor as a creative hotspot

I am a resident of Ascot Road. I have attended numerous planning committee meetings relating to the 2250 Ann Arbor Saline project. In agreement with many of my neighbors, I have expressed multiple concerns about the project.

The R4B rezoning continues to raise a number of concerns. These include:

- 1. Violation of the city's Master plan. Single-family detached units were recommended adjacent to the Lansdowne Subdivision.
- 2. The large proposed building that will be visible from several homes in our neighborhood is out of character with our neighborhood.
- 3. The existing woodland and green space in this area, including landmark trees, will be destroyed.
- 4. The large volume of additional traffic in an out of the large proposed complex will generate multiple traffic safety issues in accident-prone zone.

The site plan itself also continues to raise a number of concerns. These include:

- 1. The woodlands will be destroyed- this is the major remaining green space after the neighborhood lost a number of Ash trees some years ago. It will take decades to recreate the existing green space.
- 2.The city, rather than a developer with financial interests, should take responsibility for the proposed retention pond type of project, after evaluating <u>multiple long-term</u> <u>solutions</u> conducted and planned by an team of experts without such conflict of interest.
- 3. Sanitary sewer volume impacts on the neighborhood, and the harmful effects of resulting footing drain disconnects that will be required.
- 4. The appearance of a massive proposed 4-level building, out of character with the neighborhood.

I request your attention to these and many other concerns of the neighborhood.
