1. Jane Klingsten - Environment and Water

Jane Klingsten, Ward Two, spoke about the impacts to water and to the environment as a result of the Toll Brothers Nixon Farm development. She urged the City to protect the City's wetlands and not to rely on the DEQ for protection.

2. Jessica Prozinski - Solicitation of Immigrant Status Ordinance (C-1)

Jessica Prozinski, 446 Larkspur, spoke about C-1, Solicitation of Immigrant Status Ordinance, urging City Council to take more action to protect immigrants, than what is proposed in this ordinance. Ms. Prozinkski expressed concern with the exceptions called out in the proposed ordinance for public safety officers.

3. Laticia Valdez - Solicitation of Immigrant Status Ordinance (C-1)

Laticia Valdez, resident of Ann Arbor, spoke about C-1 and urged Council to support the proposed ordinance. She suggested strengthening the ordinance with more defined protections for undocumented residents in Ann Arbor.

4. Keysha Wall - Solicitation of Immigrant Status Ordinance (C-1)

Keysha Wall, Organizer for Stop Trump Ann Arbor, spoke about C-1. Ms. Wall expressed concern about the limitations of the ordinance and urged Council to remove the language allowing public safety officers to ask about immigration status.

5. Alexandra Shultz - Solicitation of Immigrant Status Ordinance (C-1)

Alexandra Shultz spoke in support of a strong ordinance protecting undocumented residents and urged Council to do more.

6. Leslie Stambaugh - Hillard Heintze Contract and the Solicitation of Immigrant Status Ordinance (CA-14 & C-1)

Leslie Stambaugh, Chair of the Human Rights Commission, spoke in support of CA-14, the contract with Hillard Heintze for an independent analysis of the Ann Arbor Police Department, stating the Human Rights Commission has worked on this issue for over two years. Ms. Stambaugh stated this vendor was supported unanimously by the Human Rights Commission.

7. Dwight Wilson - Professional Services Agreement with Hillard Heintze (CA-14)

Dwight Wilson, Human Rights Commissioner, spoke in support of CA-14, stating he worked on the sub-committee that studied this issue and the actions of the Ann Arbor Police Department. He stated Ann Arbor's policy should be a Human Rights model for other communities.

8. Kathy Griswold - RRFB on Fuller Road at the Crosswalk at Huron High & Entrance to Gallop Park (DC-4)

Kathy Griswold, Ward Two, spoke about the Huron High School crosswalk where a student was killed last Fall. She spoke in support of DC-4, which would improve the Huron High/Fuller Road crosswalk with an RRFB on Fuller Road and a pedestrian refuge island. She urged Council to approve this resolution and make the improvements to this crosswalk.

9. Alissa Beveridge - RRFB at Fuller Road Crosswalk (DC-4)

Alissa Beveridge, 2651 Geddes, A2 Safe Transport, urged Council to make the improvements to the Huron High crosswalk, including the installation of a new RRFB and a narrowed road.

CC COMMUNICATIONS FROM COUNCIL

COUNCILMEMBER EATON

Councilmember Eaton announced that he represents City Council on the Ann Arbor Schools Transportation Safety Committee. This group met on February 7 and updates were provided regarding the Schools' grant applications for Safe Routes to School at Huron High and Northside Elementary.

Councilmember Eaton also reported on a neighborhood meeting regarding the proposed Circle K site plan. The developer is hosting this meeting at Morgan and York on Packard Road at 6:30 p.m. on Wednesday, February 22.

COUNCILMEMBER LUMM

Councilmember Lumm stated a public meeting regarding the Arlington Boulevard street resurfacing project will be held at Tappan Middle School on March 1 between 7 and 8:30 p.m.

COUNCILMEMBER GRAND

Councilmember Grand updated Council on the newly created Student Advisory Committee. She stated all members have been appointed and a first meeting will be scheduled soon.

COUNCILMEMBER SMITH

Councilmember Smith updated the public regarding the sinkhole at Seventh and Willow across from West Park. He stated this is due to a sanitary sewer main break and will be repaired in the next few days.

COUNCILMEMBER WARPEHOSKI

Councilmember Warpehoski addressed recent attacks on immigrant populations as well as the Muslim community. Councilmember Warpehoski stated the Muslim community is hosting an Open House on Sunday, March 19 from 4:30 to 8:30 p.m. at their mosque on 2301 Plymouth Road. He stated families are welcome and the public may observe the prayers and ask questions.

COUNCILMEMBER KAILASAPATHY

Councilmember Kailasapathy addressed the community's interest in sanctuary city status, stating while the City has to act quickly in response to decisions made at the federal level, there are other considerations as well, including the risk to those who are receiving federal housing dollars.

COUNCILMEMBER ACKERMAN

Councilmember Ackerman spoke about item CA-13, the Resolution to Approve Amendment 1 to the City/DDA Parking Agreement. He stated this amendment will bring an additional \$600,000 to the City's General Fund.

Kathy Griswold, Ward Two, thanked Council, staff and City Administrator Howard Lazarus for their support of the resolution to fund an RRFB. She thanked Mr. Lazarus for his support of best engineering practices with regard to pedestrian safety.

Sara Rosenthal spoke in support of the proposal discussed tonight to strengthen the language in the Solicitation of Immigrant Status Ordinance. She urged Council to support human rights and work out the funding concerns.

Steve Carter, Ward 5, spoke about Ordinance C-1, stating Ann Arbor is wealthy and federal funding shouldn't be an issue when making this decision.

Jim Mogensen spoke about C-1, urging Council to support a strong ordinance. He talked about the funding issues.
