Amendment Number One to Agreement Between The City of Ann Arbor on behalf of the 15th Judicial District Court and The Washtenaw County Sheriff's Office

The City of Ann Arbor ("City"), a municipal corporation, on behalf of the 15th Judicial District Court ("Court"), with offices located at 301 E. Huron Street, Ann Arbor, MI 48104 and the Washtenaw County Sheriff's Office, located at 2201 Hogback, Ann Arbor, MI 48105, agree to amend the agreement to provide drug abuse screening to participants of the 15th Judicial District Court Veterans Treatment Court, Mental Health Court and Sobriety Court executed by the parties dated February 24, 2017 as follows:

1) Article V – Compensation, is amended to read as follows:

ARTICLE V - COMPENSATION

Upon completion of the above services and submission of detailed invoices for each Court as specified in Article IV above, the City on behalf of the Court will pay the Contractor an amount not to exceed Twenty Nine Thousand Seven Dollars and Twenty-One Cents (\$29,007.21) (Veterans Treatment Court NTE \$9,689.43, Mental Health Court NTE \$18,317.78 and Sobriety Court NTE \$1,000.00) for all services rendered under this contract for Grant Fiscal Year 2017 subject to the restrictions stated in Article V below.

These services are funded through grants from the Supreme Court of Michigan State Court Administrative Office Veterans Treatment Court Grant Program (SCAO-MVTCGP) (\$9,689.43), the Michigan Mental Health Court Grant Program (SCAO-MMHCGP) (\$18,317.78) and the Michigan Drug Court Grant Program (SCAO-MDCGP) (\$1,000.00) for Grant Fiscal Year 2017.

The parties agree that the City on behalf of the Court will compensate the Contractor only to the extent that SCAO-MVTCGP, SCAO-MMHCGP and SCAO-MDCGP funds are actually awarded to and received by the Court.

The Contractor shall keep complete records of services provided so that the City or SCAO may verify invoices submitted by the Contractor. Such records shall be made available to the City or SCAO upon request and submitted in summary form with each invoice

All terms, conditions, and provisions of the original agreement between the parties executed February 24, 2017, unless specifically amended above, are to apply to this amendment and are made a part of this amendment as though expressly rewritten, incorporated, and included herein.

This amendment to the agreement between the parties shall be binding on the heirs/successors and assigns of the parties.
