 Labor Contract Resolution
 Signing of Contract Between Ann Arbor Area Transportation Authority And Transport Workers Union, Local 171

WHEREAS, the collective bargaining agreement ("labor contract") between the Ann Arbor Area Transportation Authority ("AAATA") and the Transport Workers Union, Local 171 ("TWU") expired on June 30, 2017, and

WHEREAS, the AAATA and the TWU negotiated an equitable tentative agreement for a new labor contract effective through March 31, 2022 prior to the expiration of the old agreement, and transit operations have continued awaiting formal approval of the labor contract by all parties, and

WHEREAS, the TWU membership has formally voted to approve and accept the tentative labor contract agreement with AAATA, now therefore

IT IS RESOLVED, that the AAATA Board of Directors approves and accepts the tentative labor contract and authorizes the Chair of the Board, the Board Secretary, and AAATA's Chief Executive Officer to sign a labor contract with the TWU for the period of July 1, 2017, through March 31, 2022.

Eli Cooper moved to authorize Signing of Contract Between Ann Arbor Area Transportation Authority And Transport Workers Union, Local 171. Roger Hewitt seconded.
