Council Priorities/Initiatives

Independent Review of Ann Arbor Police Department Community Engagement Practices. While an additional outreach session is being coordinated with the Human Rights Commission, the City's consultant (Hillard Heintze) is preparing its draft report. We can anticipate receiving the draft in mid-September.

Equity Training. The City and County are proposing a partnership to continue Government Alliance on Race and Equity (GARE) training Phase 2. A resolution will be on the September 18th Council Agenda for your consideration.

Previews

September 5th **Council Meeting.** The following items of interest are currently scheduled:

- Council will consider a Resolution to Approve Fiber and Conduit Use Agreements with the Ann Arbor
 Area Transportation Authority, the Ann Arbor District Library, and the Downtown Development
 Authority. This item follows from the installation the City's I-net.
- Council will consider a public hearing and second reading of reading An Ordinance to Amend Sections
 1:553, 1:555, and 1:605 of Chapter 18, Employees Retirement System, Title I of the Code of the City
 of Ann Arbor, to Limit Participation by Certain Part-Time Employees, to Implement Changes
 Required by Federal Law Related to Military Service and to Correct a Scrivener's Error.

- Council will consider at first reading An Ordinance to Amend Section 9:70 of Chapter 108 (Disorderly Conduct) Of Title IX of the Code of The City Of Ann Arbor
- Council will consider a **Resolution to Approve the Distribution of the Draft Plan, The Treeline Allen Creek Urban Trail Master Plan, (CPC Recommendation: Approved 6 Ayes and 0 Nays).**

WIP (Work in Progress)

Deer Management. Staff is preparing the 2017-2018 deer management requirements, and will present program activities to Council later in the fall.

Plymouth/Green Construction Project. Work is on schedule for completion by the end of September.

Non-Union Compensation Study. Staff attended kick-off sessions on August 22nd, and is actively completing position reviews. The final report is due toward the end of the calendar year.

Other

September 11th Council Work Session - City Revenue Discussion. The work session will provide a forum to discuss revenue requirements and options, including a presentation on the framework for a potential City income tax.

September 12th Economic Development Summit: A Community Conversation about the Future of Affordability and Quality of Life in Ann Arbor. The Ann Arbor Economic Development Summit will be held on September 12th from 9 a.m. to 4 p.m. at Palmer Commons on the University of Michigan campus. The event will feature panelists who are leaders in the private, non-profit, and public sectors of our community as well as the University of Michigan. The event will be professionally moderated by Julia Novak of Novak Consulting Group (http://thenovakconsultinggroup.com) and is open to City Council and public.
