## AC COMMUNICATIONS FROM THE CITY ADMINISTRATOR

City Administrator Howard S. Lazarus presented the following reports for information of Council and reported on the following:

Mr. Lazarus provided an update regarding the City's network and internet failure that occurred beginning in the early morning hours of November 9. He thanked City staff for their hard work and efforts to continue City business without the use of the network or computer technology.

Mr. Lazarus reminded City residents to check their smoke detector batteries, noting that this should be done every 6 months with the change to and from Daylight Savings Time.

The DDA has completed its work updating the rooftops of the City's parking structures with fencing, as a suicide-prevention measure.

Mr. Lazarus reminded residents not to "crowd the plow" during snowplow season.

Mr. Lazarus recognized the City Clerk's Office for their work on a successful election and the implementation of new voting equipment on Tuesday.

Mr. Lazarus reminded Council and the public of two upcoming Work Sessions, November 13 and 16, a joint session with the DDA and the Human Rights Commission, respectively.

Mr. Lazarus thanked the AAPD officers in attendance at tonight's meeting, Sgt. Craig Lee and Officer Mike Fechik.
