INGLIS HOUSE HISTORIC DISTRICT

AN ORDINANCE TO AMEND CHAPTER 103 (HISTORIC PRESERVATION) OF TITLE VIII OF THE CODE OF THE CITY OF ANN ARBOR BY ADDING SECTION 8:425.15, INGLIS HOUSE HISTORIC DISTRICT.

The City of Ann Arbor ordains:

<u>Section 1</u>. That Chapter 103 of Title VIII of the Code of the City of Ann Arbor be amended by adding Section 8:425.15 creating the Inglis House Historic District to read as follows:

8:425.15. Inglis House Historic District.

The Inglis House Historic District is intended to include the property commonly known at the time of adoption of this ordinance as 2301 Highland Road, Tax Parcel ID number 09-09-27-301-008. The boundaries of the Inglis House Historic District are as shown on the map on file in the office of the City Clerk, which is incorporated into and made a part of this chapter, and are described as:

A parcel of land being a part of the Southwest 1/4 of Section 27, T2S, R6E, City of Ann Arbor, Washtenaw County, Michigan described as:

Beginning at a point on the East-West 1/4 line of Section 27 also being the Northeast corner of "Highland Terrace" according to the plat thereof recorded in Liber 16 of Plats, page 1, Washtenaw County Records; thence N87°25'24"E 278.45 feet along said East-West 1/4 line to a point which is 16.5 feet East of the Northwest corner of East 1/2 of the Southwest 1/4 of said Section 27; thence S01°33'26"E 1146.87 feet parallel and 16.5 feet East of the West line of the East 1/2 of the Southwest 1/4 of said Section 27; thence S87°42'34"W 16.5 feet to the Northeast corner of Lot 19 of "The Highlands" according to the plat thereof recorded in Liber 5 of Plats, page 11, Washtenaw County Records; thence continue S87°42'34"W 385.72 feet along the North line of "The Highlands"; thence Northwesterly 183.93 feet along a curve to the left, a radius of 182.7 feet, chord bearing N46°20'38"W 176.58 feet along the Northeasterly right of way of Highland Road; thence the following five (5) courses along the Easterly right of way line of Regent Drive: thence N15°28'24"E 81.18 feet; thence Northwesterly 73.57 feet along a curve to the left, a radius of 150.54 feet, chord bearing N1°28'24"E 72.84 feet; thence N12°31'36"W 19.57 feet; thence Northeasterly 47.25 feet along a curve to the right, a radius of 140 feet, chord bearing N2°51'26"W 47.03 feet; thence N06°48'44"E 27.22 feet to the South line of "Highland Terrace"; thence S89°22'36"E 196.37 feet along said South line; thence N13°19'24"E 97.31 feet along the East line of "Highland Terrace"; thence N01°32'36"W 691.64 feet along said East line to the Point of Beginning.

Section 2. That this ordinance shall become effective 10 days after publication.
