The City has received notification from the **National Flood Insurance Program** that our community has met the requirements for improvement to **Community Rating System (CRS) Class 6**. The new rating is effective October 1<sup>st</sup>.

The **Ann Arbor Farmers Market** is launching a new **Market-to-Chef** program to make buying local food easier for Ann Arbor restaurants and chefs. Starting in June, participating chefs will receive a weekly email of updated local product availability lists from each of our participating vendors, including prices. Chefs can use this online tool to submit orders and see what's in season. We will also offer drive-in, pick up zones for easy access to the market. With over 120 vendors, chefs can access the freshest produce around, and thousands of varieties of products. R-18-039 <u>Resolution Creating an Advisory Task Force to Make Recommendations Regarding the</u> <u>Roles and Responsibilities of a Community Policing Commission</u> was approved at the February 5<sup>th</sup> Council

meeting. In accordance with this resolution, a resolution to confirm nomination of the task force members were approved at the March 19, 2018 Council Agenda. The City Administrator is coordinating next steps.

# WIP (Work in Progress)

**List of Roads for Reconstruction, Resurfacing and Preventative Maintenance for 2018.** The City of Ann Arbor has released the tentative list of roads to be part of 2018's reconstruction, resurfacing and preventive maintenance program. This year's construction season will see a complete reconstruction of North Fifth Avenue and Detroit Street in Kerrytown, in collaboration with the Downtown Development Authority, as well as resurfacing of 24 segments of road throughout the city. In addition, stretches of 44 major streets and local roads will have preventative maintenance performed, which takes only a few days to complete but will help extend their useable life and improve traveling conditions. <u>A map</u> (PDF) and more information about these and other road/utility projects in Ann Arbor can be found at a2gov.org/engineering.

### Other

Ann Arbor Fire Department hosting "Firehouse Friday" on April 6 from 6-9 a.m. W4 Country 102.9 will broadcast live at Ann Arbor Fire Station 6, located at 1881 Briarwood Circle. The event is an open house and the public is welcome! Along with AAFD, staff from Ann Arbor Police Department, Human Resources, American Red Cross, Washtenaw County HazMat, and Washtenaw County Technical Rescue will be present.

The Michigan Department of Transportation is currently planning **a road rehabilitation project on N. Main from Huron St. to M-14 in 2022**. While MDOT currently does not have funding available for improvements outside of the roadway, the City of Ann Arbor is looking to ensure MDOT's design process includes a robust engagement with community stakeholders and is coordinated with locally prioritized corridor improvements. Eli Cooper, City of Ann Arbor Transportation Manager will coordinate the city's engagement along with a stakeholder list for this important process. First meeting to be held on April 9th at 10:00AM at 200 N. Main in the Lower Level Conference Room.
