According to the slides presented at the work session, 'Charges must be associated with the cost to serve. Funding for programs to provide assistance to customers with affordability challenges must be funded through not-rate revenue"

I also want to remind you the issue is peak vs base demand. Imagine we met peak demand with a separate system: all new pipes, new pumps, new treatment. WE had to pay to install that system, upkeep it, etc, but we only got to run it and bill for it 3 months a year. The base demand system, however, we got to bill for every month of the year. From a cost-to-serve perspective (which MI law requires we consider), that is what drives the tiers.

I respectfully request that you vote No on the Proposal to change the Rate Fee Structure for Water consumption in Ann Arbor.

The Rate Study that produced this Water Rate Fee Proposal had a flawed Foundation: "Affordability through rate and non-rate programs." That flawed objective resulted in a convoluted and inequitable proposed rate structure.

If one wants to address 'affordability' in water rates, one sets up a well-structured subsidy program. That is, provide a stipend to help pay for water consumption for identified households. This could be based on the rules for subsidized housing, or on household income and family size guidelines. It takes some work to organize and administer, but it is legal, and it meets the stated affordability objective.

Instead, this Proposal gerry-rigs the water rates to meet this "affordability" criterion. The data used to evaluate income levels of renters vs. owners is based on census data from 2010, so it does not account for rental properties built in the past 5 years, and it does not account for the very large percentage of students who rent -- students who have little or no income, which skews median income of Renters significantly downward.

I do not have a personal stake in this, my water bill would likely decrease under this Proposal. Still, I object to the proposed rate changes given the flaws in objective and analysis.

Please vote No on the Water Rate Proposal. Thank you.
