1. Blaine Coleman - Boycott Israel

Blaine Coleman, PO Box 7030, demanded a boycott against Israel due to that nation's crimes against Palestinians.

2. Mozhgan Savabieasfahani - Boycott Israel

Mozhgan Savabieasfahani, PO Box 7030, urged City Council to boycott Israel and to hold a public hearing on the subject. She asked how the Council could stand against gun violence, but not stand with Palestine against the violence by Israel.

3. Alan Haber - Library Lot Petition

Alan Haber, 531 Third Street, spoke about the Library Lot and the successful citizen-initiated petitions for a Center of the City ballot question. He questioned why the City continues to try to sell the property despite the certification of the petitions.

4. David Hall - Permaculture

David Hall, 424 Little Lake #615, spoke about permaculture, an emerging design science. He asked if the City was applying any design principles of permaculture in their planning practices. He stated a presentation is taking place on June 30 to further promote this new concept.

Gwen Nystuen, 1016 Olivia, expressed concern about the draft ordinance, including the fact that the changes cannot easily be tracked, and said she would like to know what the proposed changes to the ordinance might be before next time.

Wendy Carman, 2340 Georgetown, member of the City's Natural Features Committee, expressed concern about the changes to the new ordinance and questioned whether any additional mistakes were made that haven't yet been corrected, or if the previous ordinance was crossed-checked with the new ordinance to ensure that errors or omissions weren't made.

A resident on Charlton Street expressed concern about the organization of the new proposed Code, noting there is no index. She stated with no index, she believes the UDC will be difficult to use.

Edward Vielmetti, 1210 Brooklyn, spoke about the process for the ordinance revisions, and stated there are many opportunities for errors and omissions. He urged Council to postpone action and allow for a further review.

Rita Mitchell, 621 Fifth, concurred with previous speakers and stated the community does not understand this ordinance. She urged Council to invite the public to help with the review.

With Council's approval, Ms. Nystuen was afforded the opportunity to make a comment after her initial statement/question at the beginning of the hearing: Gwen Nystuen, 1016 Olivia, stated she wanted to see the strike-outs and the proposed new language in the draft and was told that wasn't possible. She said she tried to review the changes herself, but it was not possible. She reviewed the definitions starting with "A." She said there were four 'As" in the old version and now there are 20. She urged Council to really look at the new UDC before approving it.

There being no further comment, the Mayor declared the hearing continued.
