CALL TO ORDER

Mayor Hieftje called the meeting to order at 7:22 p.m. in the Guy C. Larcom Jr., Municipal Building, 2nd Floor Council Chambers, 100 N. Fifth Avenue.

INT-1 09-0577 Proclamation Relay for Life Days June 20 & 21, 2009

Mayor Hieftje read a proclamation proclaiming Saturday, June 20 & Sunday, June 21, 2009 as Relay For Life Days, recognizing the important efforts of the American Cancer Society. The Mayor encouraged all citizens to actively participate in the Relay For Life of Ann Arbor at Concordia University as a show of support to fight the disease, to increase awareness, and to honor cancer survivors. 1. Gwen Nystuen - Parking meters in residential neighborhoods

Gwen Nystuen, 1016 Olivia, representing the North Burns Park Association Advisory Board, spoke in support of the resolution to open the budget process so that the \$380,000.00 in revenue proposed to be obtained by the installation of parking meters in residential neighborhoods adjacent to downtown can be replaced with other sources of revenue.

2. John Hilton - Parking meter proposal

John Hilton, 701 N. Fourth Ave., representing the North Central Property Owners Association, spoke in support of the resolution to install parking metering equipment at limited locations in neighborhoods near the downtown area.

3. Robert Snyder - Parking meters in residential neighborhoods

Robert Snyder, 2511 Elm St., representing the South University Neighborhood Association, spoke in opposition of the city's proposed plan to install parking meters in residential neighborhoods surrounding and adjacent to the University Medical Center and the central downtown business districts.

4. Ann Schriber - Parking meters in residential neighborhoods

Ann Schriber, 2116 Dorset, speaking on behalf of the Oxford Neighborhood Association, read a letter from the association expressing their opposition to the installation of parking meters in neighborhoods near the downtown area.

5. Thomas Partridge

Tom Partridge, 4220 Eyrie Dr., said that Ann Arbor's Master Plan must assure affordable housing on a non-discriminatory basis throughout the City. The plan must assure equal access to transportation throughout the City, County, and the region.

6. Jim Mogensen - City Council Electronic Communication

Jim Mogensen, 3780 Green Brier, addressed Council regarding City Council communication. He encouraged Council to refrain from electronic communications during meetings if they do not want their messages to be displayed on the front page of the News.

7. Phelps Connell - Airport Expansion

Phelps Connell, 1696 Ct., spoke in opposition of the proposed expansion of the Ann Arbor Airport.

8. Henry Herskovitz - Palestine

Henry Herskovitz, 404 Mark Hannah Place, addressed Council regarding Palestine.

9. Ed Fontanive - E. Huron St.

Ed Fontanive, 505 E. Huron St. spoke in support of the proposed zoning of E. Huron St. from D-1 to D-2.

10. John Floyd - Shared high level vision of the future of Ann Arbor

John Floyd, 519 Sunset Rd., addressed Council regarding a shared high level vision of the future of Ann Arbor.

COMMUNICATIONS FROM COUNCIL

MAYOR HIEFTJE

Mayor Hieftje clarified that there is not a growing budget deficit in the City. The Mayor noted that the City will end this budget year with a surplus and that City staff have taken action during the budget process to ensure that there will not be a budget deficit next year. The budget year starting in July 2010 will be a difficult budget to prepare and the public will see City staff begin this process soon.

COUNCILMEMBER ANGLIN

Councilmember Anglin said the Council will face decisions tonight and in the future about the zoning in the City. Councilmember Anglin discussed the importance of the A2D2 zoning decisions and their impact on the future of the City. Councilmember Anglin encouraged his colleagues on Council to spend more time on issues that affect the quality of life of Ann Arbor residents.

COUNCILMEMBER HIGGINS

Councilmember Higgins forwarded copies of zoning area height and placement maps and asked councilmembers to assist in getting this information out to constituents and to encourage residents to attend the upcoming Ward Meetings. Ward 2 will meet this week, Ward 3 is scheduled for July, Ward 4 will be in late July and Ward 5 is scheduled for early August.

Councilmember Rapundalo announced that the Ward 2 meeting is this June 17, 2009 at 6:30 p.m. at the Traverwood Library Branch.

Resolution Returning City Place Site Plan to Planning Commission

A public hearing was continued from June 1, 2009 on the proposed Resolution to Approve City Place Site Plan and Development Agreement, 1.23 acres, 407-437 South Fifth Avenue. Notice of public hearing was published May 24, 2009.

Jim Mogensen, 3780 Green Brier, stated this is a "by right" project and represents a failure of the community. He urged Council to correct the zoning problems for the future.

Tom Luczak, S. Fifth Avenue, thanked Council for reviewing the R4C zoning. He encouraged Council to place a moratorium on development in this zoning classification until the zoning could be reviewed.

Alex de Perry, project owner, explained the project to Council, stating that they have met all of the City's code and zoning requirements. He was also available to answer questions of Council.

John Floyd, 516 Sunset Road, encouraged Council to follow a process for approval of projects.

Scott Munzel, representing the applicant, reminded Council that the existing units are already apartments, not single-family homes. He stated this area is not an historic district.

Fred Beal, 112 S. Main St., stated the project is beneficial to the downtown and more residents are needed in this area.

Brad Moor, architect for the project, spoke about the meetings the development team has had with City staff. He asked that Council apply the same standards to this project as past projects.

An unidentified First Ward resident stated he wants to live in a city that has cultural and historical significance.

Ray Detter, 120 N. Division, Apt. 1, spoke in opposition to the proposed plan. He stated it is not consistent with the downtown plan.

Lou Glorie, 827 Brooks Street, spoke in opposition of the proposed City Place Site Plan.

There being no further comment, the Mayor declared the hearing closed.

Resolution to Approve Downtown Plan Amendments (CPC Recommendation: Approval - 7 Yeas and 0 Nays)

A public hearing was conducted on the proposed Resolution to Approve Downtown Plan Amendments. Notice of public hearing was published June 14, 2009.

Elizabeth Walker, 505 E Huron St., expressed concerns about Huron being zoned D-1 between State and Division. She stated a transition zoning is needed.

Hugh Sonk, 505 E. Huron, spoke about the D-1 zoning of Huron Street, expressing concerns about building heights and traffic.

John Etter, attorney for Sloan Plaza, encouraged Council to consider a D-2 zoning for Huron Street. He provided City Council with a letter from the Michigan Department of Transportation regarding their concerns about the proposed rezoning of Huron Street.

Laser Greenfield, stated D-2 is the preferable zoning for Huron Street.

Maurice Binkow, 505 E. Huron, prefers D-2 zoning for the Huron Street area.

Kerry Wiesner, 2790 Kimberly Road, stated she is a Huron Street property owner and she is not asking for any change. D-1 zoning protects her existing property rights.

Rita Mitchell, 621 Fifth St., expressed concern about the Downtown Plan coming after A2D2. She stated this plan should be the City's vision and should have been in place before the work was done on A2D2.

Margaret Wong, 418 S. First St., spoke in opposition to the proposed downtown plan amendments. She asked that Council not be quick to vote on the proposal tonight.

Judy Swass, 625 Church St. property owner, stated the amendments to the plan impact her property.

Dan Kaplan, 625 Church St. owner, spoke in opposition to the amendments to the Plan.

Joe O'Neil, 1920 Scottwood, expressed concern that the Allen Creek Greenway non-profit organization was not contacted for input into this process.

Khamis Ziadeh, 633 Church, stated the D-1 zoning is needed.

Mark Zahn, 6431 Marshall Rd., on behalf of father at 401 E. Huron and 110 N. Division, spoke in support of the proposed D-1 zoning.

Bruce Thompson, 2682 Whiteoak Dr., spoke in support of the D-1 zoning.

Ray Detter, Downtown Citizens Advisory Council, stated all of their members reviewed the Plan. He spoke in opposition.

Maggie Ladd, Director of South University Area Association, spoke in support of the Plan amendments.

Grace Singleton, 422 Detroit St., encouraged Council to zone all of the Zingerman's properties in this area as D-2.

Ray Fulterton, 505 E. Huron, spoke in support of the D-2 zoning for E. Huron Street.

Ken Klein, architect representing Zingerman's, urged Council to approve the plan. He stated it is not perfect, but is a good framework.

Jerry Peters, employee in the downtown area, encouraged Council to continue to think about density and low-income housing options in the downtown.

Alice Ralph, 1607 E. Stadium Blvd., expressed concerns about the process.

Thomas Partridge, 4220 Eyrie Dr., asked Council to consider State and world issues, not just local ones.

John Floyd, 519 Sunset, stated he is waiting to hear about Council's high level vision and would like the Council to share it with the public as promised after last year's elections.

David Doyle asked Council to consider the community's visions.

There being no further comment, the Mayor declared the hearing closed.
