# Safety Notes

**A2** Be Safe! Check out the <u>tips and resources</u> on the city website to help ensure safe travels for all, including:

**Accident Reductions at Public Works.** A big round of applause goes out to the employees, supervisors, and managers at Public Works. Over the last several years a large amount of collective effort has gone into making sure that safety is a top priority. These efforts are paying dividends in the form of huge reductions in injuries rates. A steep downward trend has been established over the last several years that amounts to a greater than 50% reduction in injuries. Please take a moment to congratulate the Public Works team members for this achievement.

#### Success Stories

*Greenbelt Program Preserves Three Additional Properties.* The City of Ann Arbor Open Space and Parkland Preservation Program, also known as the Greenbelt Program, is happy to announce it just closed on three land protection projects.

- A 27.5 acre conservation easement on Seeley Farm, a certified organic vegetable farm in Ann Arbor Township. Washtenaw County also contributed toward the purchase price.
- Drake Farm in Lodi Township, a 72-acre agricultural operation that is a family-owned dairy, also grows corn and hay. Funding came from the USDA-NRCS under their Agricultural Conservation Easement Program (ACEP), Washtenaw County and Lodi Township in addition to the Greenbelt. The City of Ann Arbor holds the easement rights.
- Shatter Family Trust, a 25-acre fee acquisition where the Greenbelt partnered with Legacy Land Conservancy, Washtenaw County and Salem Township. Legacy was the lead on this project and now holds the preserve, which will ultimately be open to the public once a trail is built. It is located about ¼ miles south of Legacy's existing Creekshead Preserve. The name of the preserve

will be the "Anthony and Rose Shatter Family Preserve." This is the 10th publicly accessible preserve that the Greenbelt contributed to.

The Greenbelt has now protected more than 5,340 acres in 57 projects; 98 acres of the protected land are part of the city's parks system. The Greenbelt Program is funded by the Open Space and Parkland Preservation Millage, a 30-year millage approved by Ann Arbor voters in 2003 that also funds the acquisition of parklands for the city's parks system and raises more than \$2 million annually. The millage is expected to generate \$80 million over 30 years. These funds are matched by locally funded programs, landowner donations and federal grants, including funding from ACEP, a Farm Bill program administered by USDA-NRCS that provides financial assistance to eligible partners for purchasing agricultural conservation easements, with the goal of helping farmers and other producers keep their land in agriculture.

**Scooter Share.** On Friday, September 7, 2018 Bird eScooters appeared in Ann Arbor, unofficially initiating the city into the era of scooter sharing services. Bird scooters launched without the city's awareness. Despite their initial popularity, the scooters are not licensed and riders may not legally ride them in the right-of-way right-of-way at this time. In the intervening week since their introduction, City staff have discussed a balanced approach to regulating this and other scooter-sharing services so we may allow their operation. We also want to ensure that the right-of-way remains safe for all users, without unnecessary obstruction for other modalities, and with respect for our obligations under the Americans with Disabilities Act.

Every community strives toward and struggles to manage a sustainable transportation system. By providing mobility options for our residents and visitors, fewer people—even if in incremental amounts over time—will drive single occupant vehicles. In cities across America this has helped to lower impacts on physical road infrastructure, calm congestion, and improve pedestrian safety. Scooter sharing and other innovative mobility services can be an important part of a city's transportation network, and an important step forward in producing mode shifts toward more sustainable transportation choices.

Preliminarily, City staff is proposing to create a basic regulatory environment for these scooter-sharing companies where they sign license agreements to operate in our right-of-way. These agreements will charge a basic franchise fee, plus a license fee for each scooter. The city will be held harmless for liability purposes, named as coinsured on each company's insurance, and will establish a fee structure and process for seizing scooters that are left inappropriately in the right-of-way. These agreements will be short term and will renew at the city's discretion to ensure compliance with our laws. Each company will be limited to operating no more than 100 scooters in our City so we can prevent them from overrunning our sidewalks and rights-of-way.

With the right balance of regulation, we believe that these mobility-sharing companies will help to strengthen the quality of life and the community environment that makes Ann Arbor such a wonderful place to live.
