1. Tonya Huffman - Safe Routes to School Infrastructure Grant (DS-2)

Tonya Huffman, 2771 Arrowwood, spoke in support of DS-2, the Safe Routes to School Infrastructure Grant for Northside STEAM Sidewalk Gap Project.

2. Megan Fenech - Northside STEAM Safe Routes to School Sidewalk Gap Project (DS-2)

Megan Fenech, Northside STEAM principal, spoke in support of DS-2, the Safe Routes to School Infrastructure Grant for Northside STEAM Sidewalk Gap Project.

3. Lester Wyborny - Ann Arbor STEAM Sidewalks (DS-2)

Lester Wyborny, 1642 Traver, expressed concern regarding the expense and environmental impacts of DS-2, the Safe Routes to School Infrastructure Grant for Northside STEAM Sidewalk Gap Project. He suggested the grant application be revised to remove Traver Road from the sidewalk gap project.

4. Dani Parker - Safe Routes to School (DS-2)

Dani Parker, 1558 Jones, former PTO President of Northside STEAM, spoke in support of DS-2, the Safe Routes to School Infrastructure Grant for Northside STEAM Sidewalk Gap Project and also addressed student safety.

5. Chuck Marshall - Northside STEAM Safe Route to School (DS-2)

Chuck Marshall, 1602 Traver, expressed concern regarding DS-2, the Safe Routes to School Infrastructure Grant for Northside STEAM Sidewalk Gap Project, stating the project should be postponed until the Traver route can be removed.

6. Rachel Toon - Northside STEAM Safe Routes to School Sidewalk Gap Project (DS-2)

Rachel Toon, 1643 Traver and teacher at Northside STEAM, spoke in support of DS-2, the Safe Routes to School Infrastructure Grant for Northside STEAM Sidewalk Gap Project and stated Traver Road does need sidewalks.

7. Claire DuVernoy - Reconsideration of Fuller Crosswalk (DC-1)

Claire DuVernoy, 641 Geddes Ridge, spoke about the motion to Reconsider the Fuller Road Crosswalk project and stated she thinks moving the existing crosswalk will create a more unsafe situation at Huron High.

9. Aubrey Patino - Millage Rebate

Aubrey Patino, Executive Director of Avalon Housing, spoke in support of the City's previous resolution dedicating a portion of the Public Safety and Mental Health Millage rebate for affordable housing.

9. Amanda Carlisle - Affordable Housing

Amanda Carlisle, Member of the City's HHSAB, spoke in support of the City's efforts to invest in affordable housing and the use of the City's rebate millage funds for support of affordable housing, as was approved by a previous City Council resolution.

COUNCILMEMBER RAMLAWI

Councilmember Ramlawi stated he would be proposing an amendment during the discussion of B-2. He stated he is proposing a 10-year allowance for connection to City services upon annexation.

Councilmember Ramlawi thanked Public Works for the extension of the City's yard waste pick-up for two additional weeks.

COUNCILMEMBER HAYNER

Councilmember Hayner spoke about the Gelman Plume and stated the CARD meeting on this issue is held every month in Scio Township on the first Tuesday. He encouraged residents to attend.

COUNCILMEMBER BANNISTER

Councilmember Bannister invited the public to a meeting at the NEW Center on N. Main to discuss the Main Street Visioning process for 2022. The meeting will be on December 6 from 12 to 2 p.m.

COUNCILMEMBER GRAND

Councilmember Grand reported that the Ann Arbor Housing Commission received new vouchers, including for children aging out of foster care.

COUNCILMEMBER GRISWOLD

Councilmember Griswold thanked the community volunteers working with the deer sterilization program.

Councilmember Griswold also spoke about the need for an expert in pedestrian safety as the City's crosswalks are evaluated.

Councilmember Griswold stated she feels that there is a lack of transparency in the City's boards and commissions appointment process.

A resident of Ann Arbor Township thanked City Council for the proposed extension of time to connect to the City's utilities, but stated the total cost is still a concern.

Carrie Brown, Ann Arbor Township resident, spoke in opposition to the annexations, stating the residents do not want to be annexed and it is cost-prohibitive.

Lisa Abrams, City resident, spoke in opposition to the City's ongoing deer culling, as well as expressed opposition to the proposed new annexations.

An unknown township resident spoke in opposition to the annexations, stating the costs are too much for those proposed to be annexed.

Mr. Brown, Hampstead Lane and Number 15 on the annexation list, expressed concern with the entire annexation process and how township residents were notified.

There being no further comment, the Mayor declared the hearing closed.

(2) If a property becomes subject to the requirements of subsection (1) because it is annexed into the city by petition of the city to the State Boundary Commission or its successor, or is annexed as the result of mutual resolutions of the City of Ann Arbor and a neighboring township that adjust the city-township boundary, and if the public water main is available and within 200 feet (61 meters) of the property line on the date the annexation of the property is final, the official notice from the city to connect within 90 days provided for in subsection (1) will not be sent to the owner of the property before [eighteen months] TEN YEARS have elapsed after the date the annexation of the property is final, OR UNTIL THE PROPERTY IS SOLD, WHICHEVER COMES FIRST. STARTING EIGHTEEN MONTHS AFTER THE DATE THE ANNEXATION OF THE PROPERTY IS FINAL AND ENDING WHEN THE PROPERTY CONNECTS. THE PROPERTY OWNER WILL PAY THE PROPERTY'S ALLOCATED SHARE OF CARRYING COSTS RELATED TO THE DEFERRED COLLECTION OF CAPITAL RECOVERY CHARGES. All the other provisions of subsection (1) still apply.

PUBLIC COMMENT - GENERAL (3 MINUTES EACH)

A resident on the 1600 block of Traver Road spoke in opposition to the Northside STEAM Safe Routes to School project, citing problems with the local process.

Susan Wright, Traver Road resident, spoke in opposition to the Northside STEAM Safe Routes to School project, stating problems with the process and lack of neighbor support of the project.

Jessica Prozinski, Community activist, spoke about Pangea Piercing on 211 E. Liberty and the racist ideology coming out of that establishment. She stated the owner has also made sexist and harassing statements toward clients. She stated the owner closed in August, but he is operating again. She asked for Council support on this issue.

Kate Stenavich, BAMN, spoke about Pangea Piercing Parlor, stating the owner is harassing women and minorities. She asked for Council support.

Tina Carmichael, STEAM PTO President, thanked Council for the discussion regarding the Northside STEAM Safe Routes to School project. She suggested a narrowing of Traver Road to help with the traffic calming issues in that area and also asked if stakeholders could all sit down in the next few weeks to work out issues before the item comes back to Council.

Scott Newell, a resident on Traver Road thanked Council and staff for their work on the Northside STEAM project. He asked that Council consider different approaches to sidewalk gap projects.

Kai Petainen, City resident, urged Councilmember Bannister to continue her lawsuit against the City to determine if the correct process was followed.

COMMUNICATIONS FROM COUNCIL

COUNCILMEMBER GRISWOLD

Councilmember Griswold apologized to Mr. Lazarus, stating her remarks regarding pedestrian safety may have been misunderstood. She stated she has worked on this issue for a long time. She also asked for a crosswalk sign on Earhart Road.

COUNCILMEMBER BANNISTER

Councilmember Bannister stated she is willing to regroup on the Northside discussion. She also stated she would like the Council Rules and Council Administration Committee meetings to include all of Council.

COUNCILMEMBER ACKERMAN

Councilmember Ackerman spoke about the City's new traffic calming project and said many projects that previously did not qualify may now be eligible. He concurred that narrowing Traver Road would result in traffic calming.

COUNCILMEMBER HAYNER

Councilmember Hayner also spoke about the City's traffic calming project. He stated traffic calming should be part of the plan with the Safe Routes to Schools policies. He thanked CTN for filming the Northside Safe Routes to School meeting. Councilmember Hayner also expressed concern about the public notice process for these meetings.

COUNCILMEMBER EATON

Councilmember Eaton stated there will be a Transportation Safety Committee meeting at 1pm at the Ann Arbor Schools Balas Building, 2555 S. State Street on Tuesday, December 4. He stated there is an opportunity for public comment at the meeting.

MAYOR TAYLOR

Mayor Taylor spoke about the City's city seal ordinance and possible ordinance changes will be coming in response to concerns by the ACLU.
