## Safety Notes

**A2** Be Safe! The City of Ann Arbor strives to incorporate safety and health in every aspect of our operations and is committed to fulfilling our moral and legal obligation of providing a safe and healthful workplace. Part of that mission requires involving staff at all levels and measuring our progress. Each year, the city conducts a safety culture survey to gauge employee opinions and gain their input on how to make their jobs safer. The most recent survey was conducted in December of 2018, and results have shown that we continue to make valuable strides when it comes to safety in our operations. Survey highlights include:

- 96% of respondents agree that the city is concerned about safety.
- 98% of respondents agree that they have a good understanding of the safety practices required for their job and understand how to keep their work area safe.

Additional questions gathered information about areas for improvement and opinions on steps the city can take to improve safety. Responses to the survey indicate that, overall, employees have positive opinions about safety and support the city's belief that improving upon our programs must be an ongoing priority! We thank all of our staff for their efforts and involvement in the safety program. We will continue to ask for their feedback and to cultivate the safety program so that it evolves with their needs and the organization's best interest. **Board and Commissions Volunteers Appreciation at the City of Ann Arbor.** The City of Ann Arbor recognized the many volunteers at the City of Ann Arbor who have dedicated countless hours of service through our boards and commissions to help make the City excellent and sustainable. The City hosted a recognition event on Saturday, January 19, 2019 at the Michigan Theater. A special thanks to Kelly Beattie, City Boards and Commissions Coordinator, for organizing the event. Changing Driver Behavior Study Final Results Show Progress. The City of Ann Arbor has received the final results of its Changing Driver Behavior Study, a collaboration with Dr. Ron Van Houten and Western Michigan University, which measured the impact of increased signage, enforcement and communication

on drivers stopping behavior at crosswalks. Overall, stopping for pedestrians in Ann Arbor increased from a mean of 28.5 percent to 65.2 percent at treatment sites, which were subject to enhanced police enforcement, and from 34.2 percent to 53 percent at the generalization sites that did not receive additional enforcement. ## **Council Priorities/Initiatives**

City Council Priorities FY20. City Council held its annual Council Planning Session on December 10, 2018 at the Ann Arbor District Library, Downtown Branch from 4:00 – 9:00 p.m. The session was facilitated by Julia Novak of The Novak Consulting Group. Staff presented on the following topics: National Citizens Survey Results, Financial Update: FY2020 Two-Year Fiscal Plan, Pavement Asset Management, Capital Improvements Program (CIP), Ann Arbor Water Supply, and Sanitary Sewer System Asset Management. City Council continued prioritization and goal setting for FY20 at the Work Session held on Mon., January 14, 2019 from 7:00 – 9:00 p.m. at the DDA conference room, 150 S. 5<sup>th</sup> Ave., Ann Arbor, MI 48104. The session was recorded for replay.

**FY20-21 Budget Planning.** City Council Work Session discussions with staff for budget purposes will be held at Larcom City Hall, Council Chambers 2nd Floor, 301 E. Huron St. 7 p.m. Meetings will be available to view live in a variety of formats including: Comcast cable channel 16, AT&T UVerse Channel 99 or live <u>webstream</u>. Citizens can also view the meeting later at their convenience via <u>CTN's Youtube</u> channel.

## **Budget Timeline:**

January - March: Council Work Sessions.

April: In accordance with City Charter, the City Administrator's Recommended fiscal year 2020 budget is submitted to City Council on April 15, 2019. City Council can only adopt one fiscal year at a time even though the city plans for multi-year budgets.

May: City Council, with at least seven affirmative votes, must adopt the budget no later than its second meeting in May (May 20).

Independent Community Police Commission Nomination Process and Timeline. The City of Ann Arbor is seeking citizens to serve on the newly formed 11-member Independent Community Police Commission, which was formed via Council resolution on Oct. 15, 2018. Interested applicants will complete an application created by the Human Rights Commission by Thursday, Jan. 31, 2019. The online Independent Community Police Oversight Commission Application includes a two-page description of the new commission's mandate and the responsibilities that will be expected of members. ## WIP (Work in Progress)

**Community Input Sought for Police Chief Recruitment Efforts.** The City's process to recruit and hire a new police chief is underway. The police chief position is currently vacant, with duties being fulfilled on an interim basis.

A primary component of the search and recruitment process is engaging with city residents, property owners, business owners, etc. so that everyone has a voice in identifying the best candidate to lead the Ann Arbor Police Department. Outreach will take place throughout this process; and the city has contracted with Strategic Government Resources (SGR) to assist with these efforts.

The first outreach initiative, <u>a survey</u>, launched to collect input that will ultimately help the city identify the most important traits, priorities, qualifications, etc., that the city's new police chief should have. All were invited to <u>take the survey online</u> or to pick up a paper copy to fill out and turn in. All surveys were required to be completed online or turned in by Monday, Jan. 14.

Applications Being Accepted for Citizens Police, Fire & Courts Academy. The City of Ann Arbor is offering those who live or work in the city an opportunity for an inside look at our local public safety and justice systems. Those 18 years old and older who are interested are invited to submit an application to attend the 2019 Jack Dentler Ann Arbor Citizens Police, Fire and Courts Academy. The program has been renamed this year to honor the memory of long-time, beloved volunteer with the Ann Arbor Police Department, Jack Dentler, who passed away earlier this year.

The deadline to apply to participate in the CPFCA program is Friday, Jan. 25, 2019, or sooner, should the 20 available spaces become filled. Find the application on the City of Ann Arbor website at www.a2gov.org/departments/police/Pages/Getting-Involved.aspx#citizens

The CPFCA is a free program that will be held at the Ann Arbor Justice Center, Ann Arbor Fire Department Fire Station No. 6, AAFD Fire Training Grounds and Washtenaw Community College. Classes will take place once a week on Tuesdays, 6:30–9:30 p.m., beginning Feb. 12 and ending April 9, 2019.

CPFCA topics will include: AAPD and AAFD history, emergency management, fire responder's role, use of force, hazardous materials, K-9 unit, investigative unit, court duties/processes and much more. Through this program, participants will gain a better understanding of the challenges facing police officers, firefighters, prosecuting attorneys, defense attorneys and judges. Participants will take part in various mock trial roles such as judge, juror member, prosecutor and defense lawyer; learn about operations of AAPD's Patrol and Support Services Division including procedures and equipment, community outreach programs and participating in a mock traffic stop; role play in scenarios, such as selecting the appropriate

fire extinguisher and demonstrating the use of that fire extinguisher to put out a small, controlled training fire; and much more.

The goal of CPFCA is for its graduates to become partners in finding solutions to the safety issues that affect their Ann Arbor communities. Graduates are expected to share their knowledge with their neighbors.
