





#### CONSTRUCTION NOTES

- 1. ALL WORK SHALL CONFORM TO THE LATEST REVISIONS OF THE CITY OF ANN ARBOR STANDARD SPECIFICATIONS AND THE MICHIGAN DEPARTMENT OF TRANSPORTATION (MDOT) 2012 STANDARD SPECIFICATIONS FOR CONSTRUCTION AS APPLICABLE.
- 2. DRIVEWAYS AND ENTRANCES TO BUILDINGS, REAL PROPERTY, AND THE LIKE SHALL NOT BE BLOCKED EXCEPT FOR SHORT DURATIONS AND ONLY WHEN APPROVED BY THE ENGINEER. VEHICULAR AND PEDESTRIAN ACCESS SHALL BE MAINTAINED AT ALL TIMES.
- 3 LOCATION AND DEPTH OF EXISTING UTILITIES AND SERVICE LEADS AS DEPICTED ON THE PLANS ARE APPROXIMATE AND SHOWN ACCORDING TO THE BEST INFORMATION AVAILABLE AND ARE TO BE FIELD VERIFIED BY THE CONTRACTOR PRIOR TO PERFORMING THE WORK. IT IS THE CONTRACTOR'S RESPONSIBILITY TO EXCAVATE AHEAD AND DETERMINE THE PRECISE HORIZONTAL AND VERTICAL LOCATION OF THESE UTILITIES. THE CONTRACTOR SHALL REPORT IN WRITING ANY CONFLICTS SO THAT THE ENGINEER MAY DETERMINE AN APPROPRIATE COURSE OF ACTION. THIS WORK WILL NOT BE PAID FOR SEPARATELY, BUT SHALL BE INCLUDED IN THE THE RELATED CONTRACT ITEMS OF WORK. ANY DAMAGE TO UTILITIES IS THE CONTRACTOR'S RESPONSIBILITY TO REPAIR AS NECESSARY.
- 4. THE CONTRACTOR IS SOLELY RESPONSIBLE FOR ANY DELAYS, DAMAGES, COSTS AND/OR CHARGES INCURRED DUE TO AND/OR BY REASON OF ANY UTILITY, STRUCTURE, FEATURES AND/OR SITE CONDITION, WHETHER SHOWN ON THE PLANS OR NOT. THE CONTRACTOR SHALL REPAIR AND OR REPLACE AT ITS SOLE EXPENSE TO AS GOOD OR BETTER CONDITION ANY AND ALL UTILITIES, STRUCTURE, FEATURES AND/OR SITE CONDITIONS WHICH ARE IMPACTED BY REASON OF THE WORK, OR INJURED BY ITS OPERATIONS, OR DURING THE OPERATIONS OF ITS SUBCONTRACTORS OR SUPPLIERS.
- 5. NO EXTRA PAYMENTS OR ADJUSTMENTS TO UNIT PRICES WILL BE MADE FOR DAMAGES, DELAYS, COSTS AND/OR CHARGES DUE TO EXISTING UTILITIES, STRUCTURES, FEATURES AND/OR SITE CONDITIONS NOT SHOWN OR BEING INCORRECTLY SHOWN OR REPRESENTED ON THE PLANS.
- 6. DURING NON-WORKING HOURS ANY OPEN TRENCH, EXCAVATION SHALL BE PROPERLY SECURED WITH PROTECTIVE FENCING AND TEMPORARY COVER. TEMPORARY COVER(S) OVER SANITARY CHAMBERS SHALL BE CAPABLE OF WITHSTANDING THE WEIGHT OF A HUMAN. THIS WORK WILL NOT BE PAID FOR SEPARATELY, BUT SHALL BE INCLUDED IN THE ITEM OR WORK "GENERAL CONDITIONS".
- TREES EXIST IN SOME AREAS WITHIN THE PROJECT LIMITS. ALL TREES SHALL BE PRESERVED AND PROTECTED AS SHOWN ON THE DRAWINGS AND AS INDICATED IN THE SPECIFICATIONS, UNLESS OTHERWISE SHOWN FOR REMOVAL. TREE TRIMMING WHERE REQUIRED WILL BE PERFORMED BY THE CITY OF ANN ARBOR WITH ADVANCE NOTICE
- THE CONTRACTOR SHALL BACKFILL EXCAVATIONS IN ACCORDANCE WITH TRENCH DETAIL(S) SPECIFIED ON THE PLANS. THIS WORK WILL NOT BE CONSIDERED ADDITIONAL AND SHALL BE INCLUDED IN THE APPROPRIATE ITEM OF WORK.
- 9. THE CONTRACTOR SHALL MAINTAIN ALL VEHICLE AND PEDESTRIAN ACCESS THROUGHOUT THE COURSE OF CONSTRUCTION.
- 10. ALL CASTINGS AND FITTINGS REMOVED DURING CONSTRUCTION ARE THE PROPERTY OF THE CITY OF ANN ARBOR. THE CONTRACTOR, WITHIN 48 HOURS, SHALL DELIVER THEM TO THE CITY OF ANN ARBOR W.R. WHEELER SERVICE CENTER LOCATED AT 4251 STONE SCHOOL ROAD. THIS WORK WILL NOT BE PAID FOR SEPARATELY, BUT SHALL BE INCLUDED IN THE RELATED ITEMS OF WORK
- 11. THE CONTRACTOR SHALL BE RESPONSIBLE FOR THE CONTINUOUS MAINTENANCE OF THE TEMPORARY TRAFFIC CONTROL DEVICES AND SOIL EROSION CONTROL MEASURES WITHIN THE CONSTRUCTION AREA AND APPROACHES TO PROJECT SITE, UNITL THE FINAL COMPLETION OF THE PROJECT. THIS WORK WILL NOT BE PAID FOR SEPARATELY, BUT SHALL BE INCLUDED IN THE RELATED ITEM OF WORK.
- 12. THE LOCATION OF MATERIAL STOCK PILES AND ON-SITE STAGING AREAS TO BE APPROVED BY THE ENGINEER. ANY MATERIALS STOCKPILED OR STORED SHALL NOT CREATE AN EROSION PROBLEM, INTERFERE WITH DRAINAGE, OR CREATE INSUFFICIENT SIGHT DISTANCE.
- 13. EXISTING STREET NAME, GUIDE, REGULATORY SIGNS, MAILBOXES, BIKE HOOPS, ETC., WHICH CONFLICT WITH THE PROPOSED CONSTRUCTION, SHALL BE REMOVED PRIOR TO CONSTRUCTION, STORED IN A MANNER WHICH WILL PREVENT DAMAGE, AND RE-SET IN LOCATIONS AS DIRECTED IN THE ITEM OF WORK "GENERAL CONDITIONS".

#### SOIL EROSION CONTROL NOTES

- ALL EROSION CONTROL MEASURES SHALL BE CONSTRUCTED AND MAINTAINED IN ACCORDANCE WITH THE CITY OF ANN ARBOR REQUIREMENTS AND PROJECT SPECIFICATIONS. EROSION 1. CONTROL MEASURES SHALL BE INCIDENTAL TO THE PROJECT
- 2. CONTRACTOR SHALL INSERT FILTER BAG ON AN INLET THAT IS ALONG THE FLOW OF DRAINAGE IN THE VICINITY OF THE WORK AREA.
- 3. ANY EROSION OR SEDIMENT FROM WORK ON THIS SITE SHALL BE CONTAINED ON THE SITE AND NOT ALLOWED TO COLLECT ON ANY INLETS IN THE VICINITY OF THE WORK AREA.
- 4. CONTRACTOR SHALL APPLY TEMPORARY EROSION AND SEDIMENTATION CONTROL MEASURES AS REQUIRED AND AS DIRECTED ON THESE PLANS. CONTRACTOR SHALL REMOVE TEMPORARY MEASURES AS SOON AS WORK IN THE AREA IS COMPLETED.

#### MAINTENANCE OF TRAFFIC

- 1. ALL MOT DEVICES SHALL CONFIRM TO MMUTCD.
- 2. CONTRACTOR TO USE SHOULDER CLOSURE AND PARKING LANE CLOSURES TO PERFORM WORK, PAID FOR AS PART OF TEMPORARY TRAFFIC CONTROL (LSUM). CONTRACTOR TO OBTAIN CITY PERMIT FOR EACH CLOSURE
- 3. ALL FLAGGING OPERATIONS SHALL BE PAID FOR AS PART OF TEMPORARY TRAFFIC CONTROL (LSUM).
- CONTRACTOR SHALL COORDINATE WITH THE CITY OF ANN ARBOR (734-794-6350) ABOUT WORK IN THE AREAS AND ANY BLOCKING OF PARKING SPACES.

#### GENERAL ELECTRICAL NOTES

- 1. ALL ELECTRICAL EQUIPMENT AND INSTALLATIONS SHALL BE IN ACCORDANCE WITH THE CURRENT NATIONAL ELECTRICAL CODE AND ANY LOCAL AMENDMENTS.
- THE ELECTRICAL CONTRACTOR SHALL BE RESPONSIBLE FOR THE ACQUISITION OF AN ELECTRICAL PERMIT AND SCHEDULING OF THE NECESSARY INSPECTIONS.
- 3. ALL ELECTRICAL EQUIPMENT SHALL BE INSTALLED PER MANUFACTURER'S RECOMMENDATIONS AND INSTRUCTIONS.
- 4. A BOUND MANUAL SHALL BE SUBMITTED UPON COMPLETION WITH MAINTENANCE INSTRUCTIONS, PARTS LISTS, AND MANUFACTURER'S WARRANTIES. ALSO, A WARRANTY FROM THE ELECTRICAL CONTRACTOR SHALL BE INCLUDED IN THIS MANUAL; ONE COPY OF THE RECORD DRAWINGS AND FINAL INSPECTION REPORT SHALL BE INCLUDED AT THIS TIME
- 5. THE CONTRACTOR SHALL INSTRUCT THE OWNER OR THE OWNER'S REPRESENTATIVE IN THE OPERATION AND MAINTENANCE OF THE ELECTRICAL SYSTEM.
- 6. WIRING DEVICES SHALL BE COMMERCIAL SPECIFICATION GRADE, COLOR TO MATCH EXISTING. WINTERIOR DEVICE PLATES TYPE AND COLOR SHALL MATCH EXISTING. PROVIDE WEATHERPROOF WHILE IN USE COVER FOR EXTERIOR RECEPTACLES.
- 7. IDENTIFY EACH JUNCTION BOX AND RECEPTACLE WITH THE PANEL & CIRCUIT NUMBER.
- 8. THE INSTALLATION SHALL NOT ALLOW WIRE NUTS. ALL CONNECTION NEEDS TO BE WITH SPLIT BOLTS, SCOTCHFIL ELECTRICAL INSULATION PUTTY AND TAPE.
- 9. 3" CONDUITS SHALL BE NMRC SCHEDULE 80. ALL CONDUITS SHALL HAVE BELLED ENDS.
- 10. ALL WIRE SHALL BE THHN/THWN.
- 11. THE POLES SHALL UTILIZE GALVANIZED STEEL ANCHOR BOLTS. NO BREAKAWAY BASES ARE
- 12. ALL FASTENERS SHALL HAVE ANTI-SEIZE ADDED. FAILURE TO COMPLY WILL RESULT IN RE-STARTING THE INSTALLATION.


