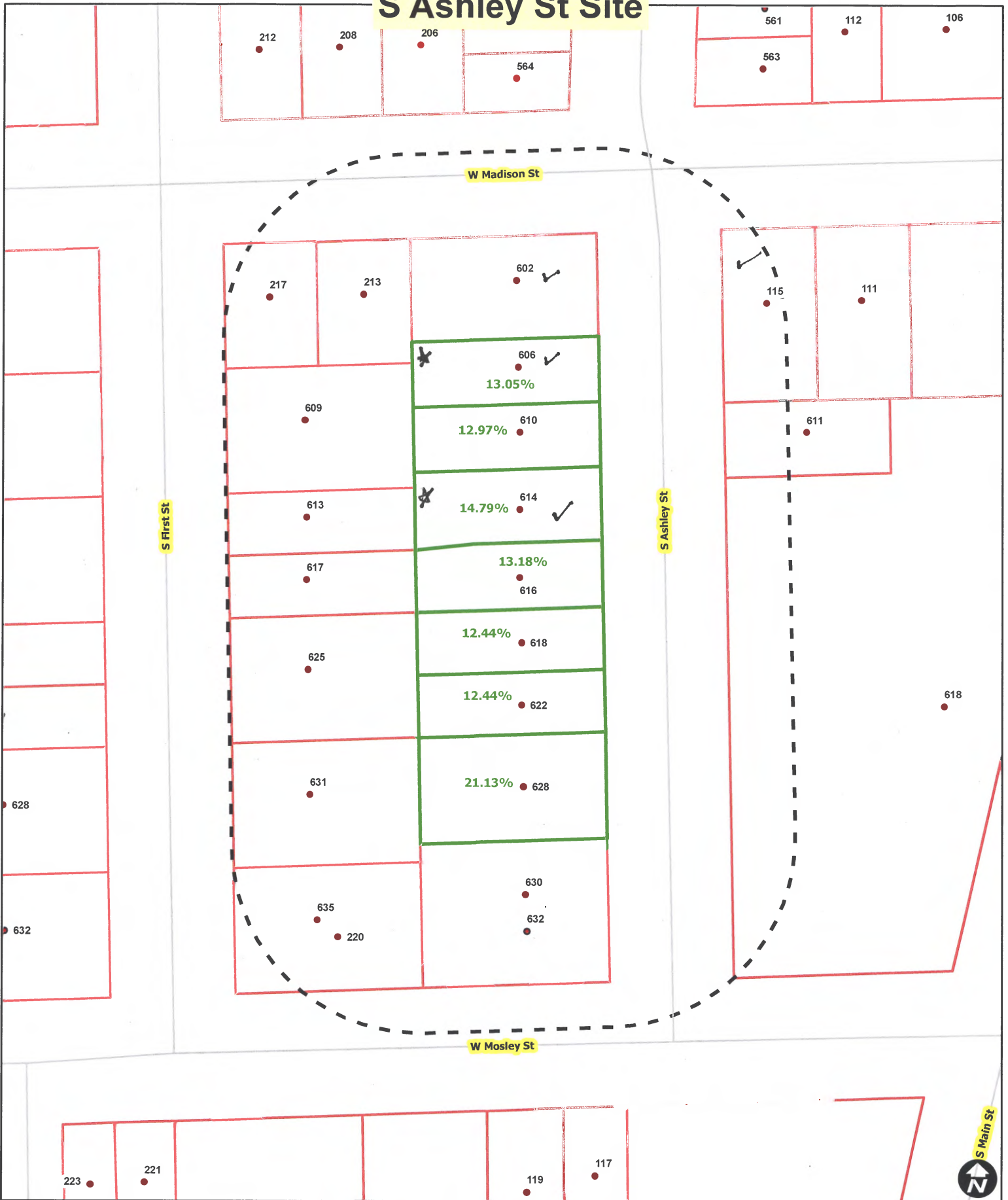


S Ashley St Site
