**d ANN ARBOR INCLUSIVE UPDATE - TOM HOATLIN/LINDA EVANS**

The episode features guest Dr. Sherry Day where a support group is discussed for helping those with visionary difficulties. Another episode will be taped on April 23 with John Waterman of the PEACEAC, which empowers those with disabilities through cycling, active transporation and self-advocacy education.*

**e PARTNERS IN ACCESS COMMITTEE - ALISON STROUD**

*A. Stroud was not present, though updates were provided by other commissioners. L. Keeler provided an update regarding a letter received regarding AAATA, which was passed along to the organization and also discussions regarding accessibility to events in the City. A suggested city ordinance was discussed that would require public event holders to state affirmatively in communications that some or all of the events may be inaccessible to those with disabilities. Z. Damon will draft an email and follow up with CM Nelson regarding moving forward with this.*

*K. Mozak-Betts posed a question if there was an ADA ombudsman with the City, which started a discussion on who that person is, what their responsibilities are and why we have not seen or heard from this individual before. Z. Damon and E. Nelson will investigate and see if there is an ADA coordinator or similar that could possibly meet with the commission on a regular basis, with a follow-up email to come from Z. Damon.*

The first was regarding Investing in Ability month (October) and the issues surrounding this.
