Safety Notes

A2 Be Safe! City of Ann Arbor Police Department Welcomes Students Back with Important Safety Reminders. With summer vacation ending and school back in session today, the streets of Ann Arbor are bustling with more vehicles, bicycles and pedestrians. This week, the entire Ann Arbor Police Department will be out in the community -- in and around schools and in neighborhoods -- to promote walking, biking and driving safety.

"Residents, students, parents, commuters and all who visit Ann Arbor must work together to help A2 Be Safe," said City of Ann Arbor Police Chief Michael Cox. "We welcome students back and want to ensure everyone enjoys a safe school year. Safety is a responsibility shared by us all."

The Ann Arbor Police Department reminds everyone of the following safety tips:

- Cross at marked crosswalks, and give motorists enough time to see you and stop. Look both ways. Don't enter the street until you see all is clear.
- Motorists, please give yourselves plenty of commute time and be patient. Pretend your child is the one crossing the road.
- See a school bus? Whether you are driving on a two-lane roadway (with or without a center turning lane) or a four-lane roadway (without a median separation), all traffic in both directions must stop when a bus stops for passengers.
- Slow down in or near school and residential areas.
- Watch for children in between parked cars and other objects.
- Be extra alert at crosswalks, and stop when pedestrians are present to cross. Drivers should also give bicyclists at least 5 feet of space on the road. (And thank you for not parking in bike lanes!)
- Look for clues such as safety patrols, crossing guards, bicycles and playgrounds that indicate children might be in the area.
- Please also watch for crossing guards and remain stopped, with the crosswalk clear, until he or she is out of the roadway.
- Residents, please be sure to keep vegetation on your property trimmed to allow for safe passage on sidewalks and proper visibility near crosswalks. If you see vegetation obstructing visibility, please report to the city via the A2 Fix It app or <u>online</u>.
- Bicyclists, ride on the road when possible and obey the traffic signs and signals. Use bike lanes when available. To report vehicles parked in marked bike lanes, please call the police non-emergency phone number at 734.994.2911.

Success Stories

Greenbelt Virtual Tours. There are now four Greenbelt "<u>virtual tours</u>" posted on the <u>program's</u> <u>web page</u>. Since the annual Greenbelt bus tour only makes three stops, the public can now see more properties via "virtual tours" than the bus tour allows.

In the short time these videos have been available, they have collectively received almost 250 views. These videos have reached over 7x the number of annual Greenbelt bus tour participants, and we expect more views and more videos to come. While the majority of properties protected by the Greenbelt Program remain in private ownership, these videos are one way for the City residents to experience the lands we've protected, and take pride in the accomplishments that have been achieved over the first 15 years of the Greenbelt Program (halfway through the 30-year millage).

Here are a few notable accomplishments to date:

- The Greenbelt has protected 20.5% of the farmland in the Greenbelt District
- The Greenbelt has protected over 19 miles of river, stream and waterway frontage. 60% of those waters are in the Huron River watershed, and contribute to the source water protection of the City's drinking water.
- The Greenbelt has helped establish 10 new public nature preserves in the region, totaling 642 acres of diverse habitats for the public to explore, with over 6 miles of trails.

CTN Brings Home Philo T. Farnsworth Video Competition Awards. Community Television Network of Ann Arbor (CTN) has been recognized with several honors in the 2019 Philo Festival of Media Arts Awards presented by the Central States Region Alliance for Community Media (CS-ACM). Over 175 entries were submitted this year from Ohio, Kentucky, Indiana and Michigan.

CS-ACM honors the memory of Philo T. Farnsworth by recognizing the efforts of modern day pioneers who work to further develop the use of this technology and promote the use of media in our communities. The "PHILO" is awarded as recognition of excellence in media creation.

CS-ACM will honor CTN and the winners of the <u>Philo Festival of Media Arts Video Competition</u> at their annual conference October16-18 at WKTV Studios, Wyoming, Michigan, <u>https://wktv.org.</u>

Public Hearings. The agenda includes two (2) Public Hearings, which are referenced below under second readings.

Second Readings.

- An Ordinance to Amend Section 5.15, Table 5-15 and Section 5.16.6 of Chapter 55 (Unified Development Code) of Title V of the Code of the City of Ann Arbor (Office District Permitted Uses, Accessory Restaurant/Bar/Food Service Use Specific Standards) (Ordinance No. ORD-19-27). Amendments are proposed to the UDC to all accessory restaurant, bar and food service use in the O district, up to 10% of the total floor area of the site or 12,000 square feet.
- An Ordinance to Amend Section 5.17.4 of Chapter 55 (Unified Development Code) of Title
 V of the Code of the City of Ann Arbor (Mixed Use Zoning District Dimensions) (Ordinance
 No. ORD-19-28). Approval of this ordinance will correct an error and clarify the standards in
 the mixed use zoning districts.

WIP (Work in Progress)

Solid Waste Resources Management Plan (SWRMP) Status. The project consultant, APTIM, submitted the initial draft of the Solid Waste Resources Management Plan (SWRMP) to the staff core team in mid-July. Following this review, the APTIM revised the report and submitted the revised final draft plan to the SWRMP Advisory Committee for their review in early August. With City Council's recent approval of Amendment #1 for the contract with APTIM, an additional fifth meeting was held with the Advisory Committee in mid-August to discuss the draft plan. The plan was then presented to the Environmental Commission at their August 22, 2019 meeting for their input and action. The draft final SWRMP and its recommendations will be discussed at the City Council work session scheduled for September 9, 2019. Staff will amend the plan to incorporate recommendations for the Environmental Commission's consideration at its September meeting, after which the plan will be presented to Council for acceptance.

Road Construction Season. Road construction season in Ann Arbor is underway with much still to accomplish in 2019. The City has plans to resurface or restore 12 major streets and 33 local streets, and an additional 40 major and local streets will undergo preventative maintenance. A list of roadways planned for construction this year is available so residents and visitors will know what to expect (and where to avoid if possible). Updates are posted on the City's road construction project page. You can also subscribe to updates.

Tools, snacks and know-how provided. Stewardship workday events are free. Michigan Supreme Court Chief Justice Bridget M. McCormack Serves as Visiting Judge in Ann Arbor District Court

"Have Gavel, Will Travel" Initiative Aimed at Raising Community Engagement

DETROIT, MI, August 29, 2019 –Michigan Supreme Court Chief Justice Bridget M. McCormack today joined 15th District Court Judge Elizabeth Pollard Hines on the bench to hear and decide cases. Chief Justice McCormack was on the bench in Ann Arbor to participate in the new initiative "Have Gavel, Will Travel" in which justices are traveling to district, circuit, and probate courts statewide and sitting on the bench. The goal of the program is to increase engagement and build ties between courts and the community. Over the previous two days, the Chief Justice shadowed Judge Hines and learned about her docket.

"We know that community engagement is critically important to increasing public trust in our judiciary," said Chief Justice McCormack. "Judge Hines and the dedicated district court staff in Ann Arbor work very hard to make sure that public interaction with the justice system is positive and efficient. Residents come to our courts at the most stressful times in their lives, and our courts are committed to treating everyone with dignity and respect."

"It was truly an honor to sit on the bench with Chief Justice McCormack," said Judge Hines. "It is gratifying that she was willing to take the time to experience firsthand what we trial court judges see every day. I really appreciate it. I think that my colleagues, court staff, attorneys and litigants did, too."

Chief Justice McCormack, and Justices Beth Clement and Megan Cavanagh, are each visiting three courts around Michigan to launch "Have Gavel, Will Travel." In each instance, the Justices will sit with a local judge on the first day, and on the second day will be hearing and deciding cases on their own as a visiting judge.

In addition to the benefits of engaging the local community and court system, the three Justices have never served as a trial court judge, so the experience will be invaluable to understand the day-to-day concerns judges see in their courtrooms, and to appreciate the critical work that is being done in courtrooms from Wayne County to Kent County to Marquette.
