AMENDMENT NUMBER 2 TO AGREEMENT FOR PROFESSIONAL SERVICES BETWEEN STANTEC CONSULTING MICHIGAN, INC. AND THE CITY OF ANN ARBOR

The City of Ann Arbor, a Michigan municipal corporation, with offices at 301 E. Huron St. Ann Arbor, Michigan 48107-8647 ("City") and Stantec Consulting Michigan, Inc., having its offices at 3754 Ranchero Drive, Ann Arbor, Michigan 48108 ("Contractor") agree to amend the professional services agreement for Construction Inspection Services executed by the parties dated March 5, 2018 ("Agreement") as follows:

1) Article II, Duration, is amended to read as follows:

Services under this Agreement shall begin after the Effective Date, and shall continue until **June 30, 2021**, unless this Agreement is terminated as provided for in Article XI.

2) Article V, Paragraph A, Compensation of Contractor, is amended to read as follows:

The Contractor shall be paid in the manner set forth in **Exhibit B-2**. Payment shall be made monthly, unless another payment term is specified in **Exhibit B-2**, following receipt of invoices submitted by the Contractor, and approved by the Contract Administrator. Total compensation payable for all Services performed during the term of this Agreement, including extensions, shall not exceed **\$1,950,000.00**.

All terms, conditions, and provisions of the original Agreement between the parties executed March 5, 2018, and Amendment Number 1 executed October 11, 2018, unless specifically amended above, shall apply to this Amendment and are made a part of this Amendment as though expressly rewritten, incorporated, and included herein.

This Amendment to the Agreement between the parties shall be binding on the heirs, successors, and assigns of the parties.

EXHIBIT B-2 COMPENSATION

<u>General</u>

Contractor shall be paid for those Services performed pursuant to this Agreement inclusive of all reimbursable expenses (if applicable), in accordance with the terms and conditions herein. The Compensation Schedule below/attached states the nature and amount of compensation the Contractor may charge the City:

Total compensation payable for all Services performed during the term of this Agreement, including extensions, shall not exceed <u>\$1,950,000.00</u>.

*Mobilization fee will only be charged a maximum of four times per project to cover administration and set up costs. Stantec does not charge for equipment and mileage costs to the City of Ann Arbor.

Notes:

- 1. Billed inspector hours shall be documented by the inspector's daily reports (IDRs). Overtime shall be for documented hours worked in excess of 8 hours per day.
- 2. All mileage, equipment, vehicle, materials, supplies, and other similar costs shall not be billed separately; but shall be included in the mobilization cost.
- 3. The costs for supervisory and administrative support staff shall not be billed separately; but shall be included in the mobilization cost.
- 4. The above rates shall be in effect through June 30, 2020. After this time, if requested by the Contractor, the rates shall be adjusted based on the consumer price index for that January.
