Housing Commission Director Jennifer Hall presented on the Housing Commission's proposed affordable and workforce housing developments.

Members of City staff present to answer questions included Derek Delacourt, Community Services Administrator; Missy Stults, Innovation and Sustainability Manager; Brett Lenart, Planning Manager; and Teresa Gillotti from Washtenaw County. Michael Johnson from the Smith Group was also present.

PUBLIC COMMENT - GENERAL (3 MINUTES EACH)

Jeff Crockett, 506 E. Kingsley, expressed concern from the Kerrytown and Old Fourth Ward Associations. He noted that parking is needed in this area as approximately 2/3 of Kerrytown customers are from out of town.

David Silkworth, Ward 5 resident, expressed concern about the loss of parking in Kerrytown. He also stated he supports the development of new workforce housing.

Stephen Ranzini, President of Bank of Ann Arbor, spoke about fundraising for affordable housing efforts, stating he is opposed to a millage as a funding source.

The owner of Found, a retail shop in Kerrytown Market, expressed concern about what the loss of parking will do to local Kerrytown merchants, stating many of her customers come to her store from out of town.

Chris Crockett, 506 E. Kingsley, urged Council to preserve the Kerrytown area, expressing concern about what the loss of parking might do to the existing businesses.

ADJOURNMENT

A motion was made by Councilmember Griswold, seconded by Councilmember Lumm, that the meeting adjourn. On a voice vote, the Mayor declared the motion carried and the Work Session adjourned at 8:53 p.m.
