## 1. Lori Saginaw - Administrative Leave of Chief Cox (DC-5)

Lori Saginaw, resident, spoke about the administrative leave of Police Chief Michael Cox. She spoke about racial inequities in Ann Arbor.

# 2. Peter Houk - Council Administrative Committee Recommendation Regarding Interim City Administrator (DC-4)

Peter Houk, resident, spoke about the appointment of Tom Crawford as Acting City Administrator. He urged Council to give him the support he needs to serve as administrator. Mr. Houk spoke about the wasteful financial costs to terminate the contract with Mr. Lazarus.

## 3. Mozhgan Savabiesafahani - Don't Postpone Gelman Cleanup Forever (DC-1)

Mozhgan Savabiesafahani, candidate for 4th Ward City Council, spoke about the clean-up of the Gelman 1,4 dioxane plume. She urged Council to request that voters approve a millage for clean-up.

## 4. Blaine Coleman - Don't Postpone Gelman Cleanup Forever)

Blaine Coleman, resident, urged Council to ask the public to support a millage for the Gelman dioxane plume clean-up.

## 5. Elizabeth Collins - Gelman Site Resolution (DC-1)

Elizabeth Collins, Ward Five resident, talked about the City's recent test results that showed 1,4 dioxane in the City's drinking water. She stated the City knows the polluter is Gelman and they need to make him clean the pollution.

## 7. Abu Ibrahim - ICPOC (INT-2)

Abu Ibrahim, resident, asked about the placement of the Chief of Police on administrative leave. He asked for answers about the leave. He talked about racial inequities in the City.

## 8. Henry Herskovitz - CC - Communications from Council (Header on Agenda)

Henry Herskovitz, resident, spoke about Council Communications, made on January 21, 2020. He asked why the City Council has not reached out to discuss issues his group has with Beth Israel congregation.

## 9. Catherine Wilkerson - Pledge of Allegiance (Header on Agenda)

Dr. Catherine Wilkerson urged Council to stand in opposition to the Pledge of Allegiance, and to support the end of the production and stockpiling of nuclear weapons.

## 10. Erik Massey - Decriminalize Nature Ann Arbor DNA2

Erik Massey spoke in support of plant-based psychedelics. He talked about the use of these plants for treatment of depression. He urged Council to support the decriminalization of these plants.

#### COUNCILMEMBER RAMLAWI

Councilmember Ramlawi spoke about his decision to support the termination of the City Administrator's contract. He stated he can't speak about the reasons due to the agreement in place, but he acknowledged the public's concern about the financial impacts of this decision. He also expressed disappointment that other members of Council did not reach out to their colleagues, prior to publishing a letter regarding the termination.

Councilmember Ramlawi thanked the members of ICPOC for speaking out about their mission and the status of the police chief.

## COUNCILMEMBER HAYNER

Councilmember Hayner stated it is challenging to be a Council Member, but he thanked the public for coming out to the meeting to support the issues that are important to them.

Councilmember Hayner stated the monthly meeting of CARD will take place this Wednesday.

Councilmember Hayner spoke about the public in attendance supporting the decriminalization of psychedelic plants and fungi.

Councilmember Hayner thanked Tom Crawford for serving as interim City Administrator. He also stated his vote to terminate Mr. Lazarus was in order to reserve the right to reconsider the vote, which he now understands couldn't easily be done.

## COUNCILMEMBER LUMM

Councilmember Lumm thanked Rev. Mashod Evans of the ICPOC for speaking out about the recent events in the Ann Arbor Police Department.

Councilmember Lumm also spoke about several items on the City Administrator's Report, including AC-2, regarding the Nixon Corridor

Improvement projects.

#### COUNCILMEMBER GRAND

Councilmember Grand stated the City has had a couple of really rough weeks. She thanked City staff for their support of Council and the community in difficult times.

## COUNCILMEMBER GRISWOLD

Councilmember Griswold concurred with other Councilmembers and said it is time to move on. She also thanked staff.

Councilmember Griswold talked about sidewalk maintenance and snow clearing. She stated she would like the Transportation Commission to look at this issue.

Councilmember Griswold talked about the dark skies ordinance that is working through the Environmental Commission. She urged the Transportation Commission to also look at this issue, expressing concern about recent crosswalk construction projects that do not have lighting.

Councilmember Bannister announced there is a new survey at A2Zero.org regarding carbon neutrality. She urged members of the public to take the survey. She stated there is also a Housing Commission survey on the City's website.
