2. SPARK Budget Adjustment Update

SPARK will be part of the offical program at the 2020 North American International Auto Show this year. The University of Michigan will partner with SPARK in the program.

Mr. Mayer reviewed the \$125,000 allocation for the auto show. The venue cost was lowered, allowing the allocation for marketing to increase. The venue fee is \$5,000 for a space in the Guardian Building in downtown

Detroit.
