The public needs to be given the password that is asked for in zoom. Otherwise the meeting is not transparent. \*9 is not enough to actually view the meeting and the PowerPoints.

The builder stated that he had informed the zoning board back in 2013 of his future intention to add 3 bedrooms in the basement. However the public was not told of that plan and this means that the city's zoning board was hiding something critical from the public in 2013 when the builder was given his first variance for 215 Packard.

Moreover the parking allowance is by unit not bedroom so adding bedrooms greatly impacts the parking pressure.

Also it is strange how the committee approved the other zoning appeal for a house on Packard last night on the grounds that bedrooms were merely being enlarged and not added to in number. That Idea was dropped for Kaplan's appeal which did entail 3 new bedrooms. It was very clear that Kaplan has become buddy buddy with City zoning officials who should be protecting the public interest and instead are serving the private interests of the builder at the expense of the public welfare and safety.

The zoning board seems to think it's fine to allow a variance that makes a structure nonconforming to zoning and then later to approve further variances on the grounds that the structure is already non-conforming. This disingenuous practice needs to be broadly exposed to the public because it shows how corrupt the zoning board has become.
