MicroSurvey is the developer and vendor for Map360 Desktop Crash and Crime Diagramming Software. After demoing other Crash Diagramming software, Map360 offers the best features for not only Crash Diagramming, but Crime Scene Diagramming as well. In addition, this software pairs seamlessly with the Leica TS13 Robotic Total Station for capturing data points to create crash scenes and outdoor crime scenes. In addition to Map360, we would purchase the Disto S910 Bundle to capture data points to recreate indoor crimes scenes and collect evidence points. The Disto S910 Bundle includes: Disto S910, Pin Pole Kit, IMS Map360 and Evidence Recorder. The Detective Bureau is currently measuring indoor crime scenes by hand (tape measures) and then hand drawing the crime scene in a rudamentary CAD program. The Disto S910 Bundle would allow for faster processing of crime scenes and creation of crime scene maps.

What activities have already occurred prior to submitting this request? Discuss what other products and services in the market were reviewed and why they didn't fulfill the need. Prior to selecting Map360 and the Disto S910 Bundle, Crash Reconstructionist Clock, Garrett and Adkins, along with Detectives Ellinger and Lee reviewed Virtual Crash and CAD Zone (Crime/Crash). Virtual Crash is an excellent tool for crash scene reconstruction, but has limited capability in mapping crime scenes. The cost of Virtual Crash is significantly higher at \$6200 for the first license and \$3999 for additional licenses. We currently use CAD Zone, but have experienced limitations when mapping indoor crime scenes. We have determined that Map360 will offer the best mapping capabilities for both crash and crimes scenes at \$1495 per license.
