Damon will be collecting more updated crash data and partnering with T. Hull on developing a recommendation on HB-4738, also to be reviewed and voted on in the next meeting.

c CHAIR REPORT - ZACH DAMON

Z. Damon gave the chair report. g TRANSPORTATION COMMISSION UPDATE - TIM HULL

T. Hull gave an update on the Transportation Commission. He informed the commission about the resolution that was passed for HB-4738 and the link he sent to the commission about it. He also discussed the comprehensive transportation update, the micro mobility committee coming back and street and sidewalk millage renewals. Finally, he also announced that RTA will be introducing a new express bus between Detroit and Ann Arbor.

K. Mozak-Betts brought up the state of the sidewalks downtown and asked what the best method is for a citizen to report concerns. E. Nelson encourages citizens to report their issues to A2fixit so the City can be made aware along with the documentation such as photos that citizens can submit with it.

h U OF M COUNCIL FOR DISABILITY CONCERNS MEETING UPDATE - KATHLEEN MOZAK-BETTS

K. Mozak-Betts provided an update on the U of M Council of Disability Concerns. She discussed a presentation made by Dr. Michelle Mead from the University of Michigan-Medicine on the topic of healthy aging for individuals and shown at this presentation was a project aiming to create a national resource center that will provide training, activities and technical assistance to the disability community.
