**PUBLIC COMMENT - GENERAL (3 MINUTES EACH)**

*John Moran, resident, discussed the decision of the University of Michigan to bring back students to campus and his concerns that it will lead to Ann Arbor becoming a Covid-19 hotspot.*

*Chuck Loucks, resident, discussed the option of moving City elections back to odd years.*

*Zachary Storey, resident, discussed Councilmember Hayner's comments at the previous meeting and Councilmember Griswold's recent comments regarding student behavior.*

*Luis Vasquez, resident, discussed his disappointment in the placement of public commentary at the end of the agenda for special meetings. He also discussed the notion that the Mayor's veto of the approval of tonight's resolution would trigger a citizen lead petition drive, as it had not done so in the past.*

*Jamie Magiera, resident, discussed his disappointment regarding tonight's vote. He encouraged Mayor Taylor to veto the resolution.*

*Joe Spaulding, California resident, discussed how the Councilmembers who voted against the resolution this evening would see this used against them in future re-election efforts.*

*Eric Sturgis, resident, thanked Councilmember Griswold for her work on Congresswoman Debbie Dingell's unity breakfast. He also discussed his belief that the voters should be allowed to decide the issue of non-partisan elections.*

*Rita Mitchell, resident, stated she appreciated the effort of Councilmember Lumm to bring the issue of non-partisan elections for Council and Mayor to a public vote. She thanked the council members who voted in favor of taking the issue of non-partisan elections to the public for a decision.*

**COMMUNICATIONS FROM COUNCIL****COUNCILMEMBER HAYNER**

*Councilmember Hayner reiterated his belief that water and electricity should not be cut off as punishment on properties that are hosting parties in excess of the Governor's limit on gatherings.*

**COUNCILMEMBER BANNISTER**

*Councilmember Bannister discussed the concern raised during public commentary that the rates of COVID-19 would increase with the return of students to Ann Arbor. Councilmember Bannister also encouraged residents to sign up for the City's new emergency alert system, Everbridge.*

**COUNCILMEMBER GRISWOLD**

*Councilmember Griswold discussed the Big Ten's decision to cancel this season's football. Councilmember Griswold also discussed her support for harsher penalties, including utility shutoffs and eviction for the unauthorized Greek organizations on campus, should they disregard the Governor's ban on large gatherings. Councilmember Griswold, also discussed the upcoming announcement from the Governor regarding the creation of an autonomous vehicle corridor, between Ypsilanti and Ann Arbor, but urged greater regulation on the vehicles to ensure pedestrian safety.*

**COUNCILMEMBER ACKERMAN**

*Councilmember Ackerman discussed the need for Council to be respectful of individuals who take the time to participate in public commentary.*

**COUNCILMEMBER RAMLAWI**

*Councilmember Ramlawi discussed his belief that the mayor needs to be a better consensus builder. Councilmember Ramlawi also discussed his*

*desire to see non-partisan elections be brought to the voters via a citizen-initiated petition.*

#### **COUNCILMEMBER GRAND**

*Councilmember Grand discussed some of the misconceptions regarding Ranked Choice voting. Councilmember Grand also discussed her objection to the name calling on Council and encouraged the rest of Council to remember that all members work with the City's best interests in mind.*

#### **COUNCILMEMBER EATON**

*Councilmember Eaton discussed Ranked Choice voting and how it is currently not permissible under State law. He noted that the current House bills that would allow for Ranked Choice Voting in Michigan would not allow it to occur on any ballot that has State and Federal offices on it.*

#### **COUNCILMEMBER LUMM**

*Councilmember Lumm apologized that she has not previously lead a petition drive to get non-partisan elections on the ballot, and vowed to work on the initiative this time.*

#### **INTERIM CITY ADMINISTRATOR TOM CRAWFORD**

*Interim City Administrator Tom Crawford discussed the level of coordination between the City and the University of Michigan in their efforts to ensure that all residents would be safe during the upcoming school year.*

#### **ADJOURNMENT**

**A motion was made by Councilmember Eaton, seconded by Councilmember Griswold, that the meeting adjourn. On a voice vote, the Mayor Pro Tem declared the motion carried and the meeting adjourned at 8:27 p.m.**
