Working with the artists to allow more conversations with them to determine artist talks, selling pieces of their works, it would be ideal to include the UM community as many are seeking ways to engage students in new activities across the city due to COVID; i.e., walking tours, community talks, education, virtual tours, etc.

Ann Arbor Art Center raised \$51K and additional fundraising continues on the back end. Prior mural installations include Grizzly Peak mural and Historic Pretzel Building by the Cup Cake Station and since then, they have continued conversations with property owners who are interested in having murals added to their locations.

#### **REPORT FROM WORK GROUPS**

Business Owners and Developers - Planned six story mixed-use building at S University and E University with residential student apartments with first two floors as retail shops. Project will create an alleyway (walkway/loading area) between E University and Church St where the developer has agreed to place mural within the project. Idea that placement of murals discourages graffiti. -

CIP - No items to share

Communication and Art Placement - No Items to share

Fundraising - Donation received within the Ann Arbor Area Community Foundation (AAACF). Discussion on how funds can be used within the current charter. Changes to the charter do not require City Council approval and are necessary to diversify its use. AAACF will review the charter with their board and move forward with suggested changes within the charter.

Leadership Forum - With new members a discussion re additional outreach is necessary

Nominating and Membership - Excited for new members to help expand what we are currently doing

Policy and Governance - Small budget request to City Council to be reviewed in December in the hopes of a final approval. Funds will allow use of budget for commission use for grant matching, etc.

Special Projects - Discussions continue on how best to bring back the Golden Paint Brush Award to raise awareness and best way to honor local artists. Determining which projects to nominate, set criteria, impact on community/public, collaborations, etc. Use current rubric to reshape details of the award, expand categories, public impact, etc. Addition of an online catalog to show examples to the public which may allow for more engagement, similar to online public art

Youth Outreach - No items to share

Items of Sharing -\*Historic Street Exhibits to be added to the public art collection which are public art that share past to present view of the historical events within the City of Ann Arbor. The Ann Arbor Historic Foundation is responsible and has raised the funding to monitor and continue to install these markers. Desire to expand upon the history of African American community within the city. Craig Hupy to have a discussion with Ray Detter on how best to showcase and maintain this collection. Add this item as part of our annual collaboration session.
