Satch Chada, Property Owner, and Kevin Brandon, and Patrick Cleary, representing the proposed project, presented the proposed project.

City of Ann Arbor City Planner Chris Cheng presented the Staff Report.

## PUBLIC HEARING

Denis Gala (address unknown), expressed opposition for the proposed project.

*Julie Weatherbee, 108 East Davis, Ann Arbor, expressed support for the proposed project.* 

*Chris (last name unknown), 1241 Summit, Ann Arbor, expressed support or the proposed project.* 

Robert Droppleman, 837 S Main Street, Ann Arbor, expressed opposition for the proposed project.

Moved by Milshteyn seconded by Sauve that the Ann Arbor City Planning Commission hereby recommends that the Mayor and City Council approve the 907 & 913 S. Main Street Site Plan and Development Agreement, subject to combining both lots before issuance of any permits and elimination of street trees outside the public right-of-way by the Zoning Board of Appeals.

COMMISSION DISCUSSION

Councilmember Lisa Disch discussed solar, parking, and landscaping.

Chada answered that the plan is to recover 30% of the building's energy using solar on site. He explained that he plans to include parking for ZipCar or similar use.

Cleary explained the landscaping proposed for the site.

Commissioner Alex Milshteyn inquired about parking at the site

Brandon explained that all parking is proposed to meet city requirements.

Commissioner Ellie Abrons inquired about plans to ensure protection of trees on the site, about open space at the site, and about electrification.

*Cleary explained the techniques planned to ensure protection of trees on the site.* 

Chada explained that he intends to install furniture like picnic tables in the open space area and that there will be natural gas utilities installed in the building.

In order to resolve a technical issue, the Planning Commission took a break from 8:18 p.m. to 8:28 p.m.

*Commissioner Sara Hammerschmidt inquired about parking assignments.* 

Chada explained that parking will be assigned by property management.

Commissioner Lisa Sauve inquired about the proposed retaining wall relating to the dripline, and inquired about package collection/storage, and encouraged electric appliances, and encouraged planning for diversifying the unit mix.

Clearly explained that the intention is to be as careful as possible, and due to the plans in place and the existing condition, the concern for any issue is low.

*Mills discussed the design flexibility, bike parking, vehicle parking, solar use, overall design,* 

Brandon explained that the intention with solar is to use the generated solar on site
