

Good evening Ms. Diamond,

Thanks for reaching out. One of the reasons ordinances are introduced before Council a minimum of two times before adoption is to allow opportunity for adequate public input, as well the identification of potential issues. Since first reading on 3/1 the feedback we've received from property managers has helped to identify a portion of the ordinance that was in need of revisions. We appreciate that feedback. It is my understanding that an amendment will be introduced tonight to address the conflicts between the draft of the ordinance posted online and obligations of landlords that accept housing vouchers and other federal housing aid. Additional language will be included to ensure that our ordinance is not in conflict in with any other federal/state requirements.

The exception that was provided to housing providers like Avalon was not intended to be "self-serving", but rather acknowledge the federal requirements these affordable housing providers must follow. Their goal is to screen residents in, not out. The federal government has created a very narrow set of criminal offenders that providers like Avalon are required to screen out.

Regarding your recommendations for what we could do, guidance provided by HUD in 2016 sought to provide clarity about the use of criminal background checks. The guidance notes, "a policy or practice that fails to consider the nature, severity, and recency of criminal conduct is unlikely to be proven necessary to serve a "substantial, legitimate, nondiscriminatory interest". Based on the comments we've received on Council from landlords and property managers in the community, I am skeptical that this guidance is being followed.

#### Mayor Taylor, Council People:

I write regarding your "Ban the Box" initiative regarding rental applications and criminal background checks. I hope that you're reviewing these comments before the second reading of the proposed ordinance on Monday, March 15, 2021. You have not engaged our expertise before making plans that greatly impact us, the residents we serve, and the community we all love. We house, and thus represent the security needs of, approximately 50% of the people in this city so the omission is unacceptable.

Had we been consulted in advance here is what we would have advised. Maybe it's not too late to either abandon or improve your plan.

1.) Almost all people believe that public avenues for rehabilitation and redemption should exist. We are no different and can provide many stories of how we extended ourselves to help individuals with criminal records get back into productive society as residents or as employees.

- 2.) It is not reasonable to force a property owner to **break federal laws related to their federal loan and/or federal lease covenants**. HUD's last directive (April 2016) on the issue of criminal background checks establishes administrative rules with which your ordinance will be in conflict. Federal loan covenants and Section 8 leasing rules, for example, will be honored over local ordinance as property owners simply will not deviate from those obligations, risking default, lawsuits and their access to federal programs.
- 3.) Exempting the city's public housing from the ordinance, besides being blatantly self-serving, will clearly create adverse disparate impacts for many. The city should not expose itself to these legal risks. Further, why provide a special carve out for Avalon Housing, Inc.? This exemption specifically speaks to intentional disparate treatment.

If you are determined to persist after considering the above please consider the following:

- 4.) The competing rights of tenants who haven't committed felonies have not been adequately considered in developing the current version of the ordinance and their safety is thereby compromised. Similarly, the safety of property management professionals (property managers, bookkeepers, maintenance and leasing staff) is compromised. In fact, the safety and security of everyone one who lives and/or works in Ann Arbor will be diminished. If we don't check criminal backgrounds there will be more unrehabilitated felons seeking safe haven here. Who wants that?
- 5.) You could, by ordinance, push the criminal background check deeper into the application process in order to eliminate initial racial bias masquerading as a criminal background check. Many property managers already do this tiered screening in coordination with 3rd party reporting agencies because they seek to keep the application process colorblind. Such policies allow screening that keep others safe and allow rehabilitated people, who have committed many types of crimes, to rent.
- 6.) You could, by ordinance, clearly define which types of felonies AND the recency with which they were committed as being subject to a fair denial. Felonies that physically hurt others should obviously be treated differently than ones that did not. Crimes against children or sexual assaults should be subject to a fair denial. Some crimes with high rates of recidivism must be known before possession is granted for the protection of the community. At the same time some egregious crimes will have happened so far in the past that we know the applicant will be very unlikely to repeat these offenses. Somehow you must allow for these realities to be known and factored into a rental decision.
- 7.) If you proceed "as is" you must indemnify all property owners and managers against inevitable lawsuits from their non-felony committing residents charging that their landlord failed to keep them safe after they've been injured by the people the city wouldn't let us screen out.

Thank you for considering my comments. I look forward to the day you reach out to us in advance of a proposed radical change that impacts us, our residents and our staffs so that we can contribute our experience in the initial stages of any ordinance planning.

Good evening Ms. Diamond,

Thanks for reaching out. One of the reasons ordinances are introduced before Council a minimum of two times before adoption is to allow opportunity for adequate public input, as well the identification of potential issues. Since first reading on 3/1 the feedback we've received from property managers has helped to identify a portion of the ordinance that was in need of revisions. We appreciate that feedback. It is my understanding that an amendment will be introduced tonight to address the conflicts between the draft of the ordinance posted online and obligations of landlords that accept housing vouchers and other federal housing aid. Additional language will be included to ensure that our ordinance is not in conflict in with any other federal/state requirements.

The exception that was provided to housing providers like Avalon was not intended to be "self-serving", but rather acknowledge the federal requirements these affordable housing providers must follow. Their goal is to screen residents in, not out. The federal government has created a very narrow set of criminal offenders that providers like Avalon are required to screen out.

Regarding your recommendations for what we could do, guidance provided by HUD in 2016 sought to provide clarity about the use of criminal background checks. The guidance notes, "a policy or practice that fails to consider the nature, severity, and recency of criminal conduct is unlikely to be proven necessary to serve a "substantial, legitimate, nondiscriminatory interest". Based on the comments we've received on Council from landlords and property managers in the community, I am skeptical that this guidance is being followed.

#### Mayor Taylor, Council People:

I write regarding your "Ban the Box" initiative regarding rental applications and criminal background checks. I hope that you're reviewing these comments before the second reading of the proposed ordinance on Monday, March 15, 2021. You have not engaged our expertise before making plans that greatly impact us, the residents we serve, and the community we all love. We house, and thus represent the security needs of, approximately 50% of the people in this city so the omission is unacceptable.

Had we been consulted in advance here is what we would have advised. Maybe it's not too late to either abandon or improve your plan.

- 1.) Almost all people believe that public avenues for rehabilitation and redemption should exist. We are no different and can provide many stories of how we extended ourselves to help individuals with criminal records get back into productive society as residents or as employees.
- 2.) It is not reasonable to force a property owner to break federal laws related to their federal loan and/or federal lease covenants. HUD's last directive (April 2016) on the issue of criminal background checks establishes administrative rules with which your ordinance will be in conflict. Federal loan covenants and Section 8 leasing rules, for example, will be honored over local ordinance as property owners simply will not deviate from those obligations, risking default, lawsuits and their access to federal programs.
- 3.) Exempting the city's public housing from the ordinance, besides being blatantly self-serving, will clearly create adverse disparate impacts for many. The city should not expose itself to these legal risks. Further, why provide a special carve out for Avalon Housing, Inc.? This exemption specifically speaks to intentional disparate treatment.

If you are determined to persist after considering the above please consider the following:

4.) The competing rights of tenants who haven't committed felonies have not been adequately considered in developing the current version of the ordinance and their safety is thereby compromised. Similarly, the safety of property management professionals (property managers, bookkeepers, maintenance and leasing staff) is compromised. In fact, the safety and security of everyone one who lives and/or works in

Ann Arbor will be diminished. If we don't check criminal backgrounds there will be more unrehabilitated felons seeking safe haven here. Who wants that?

- 5.) You could, by ordinance, push the criminal background check deeper into the application process in order to eliminate initial racial bias masquerading as a criminal background check. Many property managers already do this tiered screening in coordination with 3rd party reporting agencies because they seek to keep the application process colorblind. Such policies allow screening that keep others safe and allow rehabilitated people, who have committed many types of crimes, to rent.
- 6.) You could, by ordinance, clearly define which types of felonies AND the recency with which they were committed as being subject to a fair denial. Felonies that physically hurt others should obviously be treated differently than ones that did not. Crimes against children or sexual assaults should be subject to a fair denial. Some crimes with high rates of recidivism must be known before possession is granted for the protection of the community. At the same time some egregious crimes will have happened so far in the past that we know the applicant will be very unlikely to repeat these offenses. Somehow you must allow for these realities to be known and factored into a rental decision.
- 7.) If you proceed "as is" you must indemnify all property owners and managers against inevitable lawsuits from their non-felony committing residents charging that their landlord failed to keep them safe after they've been injured by the people the city wouldn't let us screen out.

Thank you for considering my comments. I look forward to the day you reach out to us in advance of a proposed radical change that impacts us, our residents and our staffs so that we can contribute our experience in the initial stages of any ordinance planning.

That being said I would like the option to deny an apartment to people that have committed violent crimes, or sex offenders.
