The May 3 Council Meeting will feature the following items of interest:

Consent Agenda. There are (14) items on the consent agenda.

Public Hearings. There are (10) public hearings which are listed below and under second reading.

- A public hearing and Resolution to Approve 614 South Ashley Site Plan (CPC Recommendation: Approval 8 Yeas and 0 Nays). Approval of this resolution will allow for the construction of a 289-square foot, second-story addition on the rear of the existing office building with three parking spaces located beneath the structure.
- A public hearing and Resolution to Approve New Fee for Fairview Cemetery. This resolution
 proposes to establish a new fee at Fairview Cemetery to cover administrative costs for the
 purchase of an additional grave space fee in cases of two cremation interments within the
 same space, during the same grave opening. It recently came to the City Clerk's Office's

- attention that a fee is required for this circumstance, as indicated in the current Fairview Cemetery Rules, but no fee has ever been established.
- A public hearing and Resolution to Approve FY 2022 Fee Adjustments for the Community Services Area. This resolution is authorizing fee adjustments and new fees for FY22 in the Community Services Area. Annually, in conjunction with the preparation of the budget, service units review fee revenues to determine if the costs of the services rendered are covered by their fees or are appropriate in relation to comparative data.
- A public hearing and Resolution to Approve Fiscal Year 2022 Fee Adjustments for Public Services Area - Engineering, Systems Planning, Public Works, Water Treatment, and Waste Water Treatment Units. This resolution is authorizing fee adjustments for FY22 in the Public Services Area. The anticipated increase in revenue resulting from the fee adjustments is important to balance expenditures and revenues in the proposed budget.
- Public Hearing Only Resolution to Adopt Ann Arbor City Budget and Related Property Tax Millage Rates for Fiscal Year 2022. This is a public hearing for the proposed FY22 City Budget. The proposed City budget totals \$510 million in revenue and \$470 in expenditures and is in compliance with City Charter. The resolution will be on the May 17th City Council Agenda.

Ordinances - Second Readings (5)

- A public hearing and An Ordinance to Amend Chapter 55 (Zoning) of 3.56 Acres from TWP (Township District) to R1B (Single-Family Dwelling District), 2260 Traver Road (CPC Recommendation: Approval 7 Yeas and 0 Nays) (ORD-21-11). Approval of this ordinance will zone this 3.56 acre parcel from TWP to R1B to allow access to City sanitary utilities. The site was recently annexed into the City.
- An Ordinance to Amend Chapter 55 (Unified Development Code), Rezoning of 1.1 Acres from TWP (Township District) to R1A (Single Family Dwelling District), 3411 Geddes Road (CPC Recommendation: Approval - 6 Yeas and 0 Nays) (ORD-21-10). This ordinance will zone this property R1A (Single Family Dwelling District) now that the property has been officially annexed into the City.
- An Ordinance to Amend Table 5.15-1, Table 5.15-2, Sections 5.33, 5.37.2.P and 5.37.2.S, of Chapter 55 (Unified Development Code) of Title V of the Code of the City of Ann Arbor (Short Term Rentals) (CPC Recommendation: Approval 8 Yeas and 1 Nay) (ORD-21-12). In September of 2020, the City enacted Chapter 97 of the City Code which established requirements for the operation, location, and licensing of short-term rentals in the City of Ann Arbor. Included in the adopted Ordinance are provisions that prohibit the operation of short-term rentals by in residential zoning districts when the location is not the principal residence of the property owner.

In December of 2020, the City Council instructed the City Administrator and Planning Commission, if applicable, to develop and proposed amendments to Chapter 97 – Short Term

Rentals and/or Chapter 55 – Unified Development Code, to create a regulatory structure that would enable the continued operation of pre-existing short-term rentals that do not meet the current requirements of Chapter 97. In response, City staff prepared the attached proposed amendment to Chapter 55 – Unified Development Code, which was recommended by the Planning Commission as responsive to the City Council Direction.

The proposed amendments:

- 1. Amendments to the Permitted Use Table –Section 5.15, Table 5.15-1
 The proposed amendments to this section add Short-Term Rental Non-Principal
 Residence as a permitted use in the Mixed-Use zoning Districts. This would enable any
 property, regardless of residence status, to be eligible for a Short-Term Rental Use in the
 identified zones.
- 2. Amendments to the Accessory Use Table –Section 5.15, Table 5.15-2
 The proposed amendments to this section add Short-Term Rental –Principal Residence –
 Homestay, and Short-Term Rental Principal Residence Whole House as a permissible
 Accessory Use in the Residential and Mixed-Use zoning districts. This would enable any
 principal residence (regardless of tenancy or ownership status) to be eligible to license
 the property for these two Short-Term Rental uses.
- 3. Amendments to Section 5.33 Nonconformities The proposed amendments to this section add new text that would have the effect of allowing Non-Principal Residence Short-Term Rentals to operate within Residential Zoning Districts, if the use was established prior to March 1, 2021 (the effective date of Chapter 97). Establishment would be determined by the City, upon the submission of evidence by a property owner seeking to invoke this provision.

A property that met this provision would be subject to the UDC provisions for non-conforming use continuation and restriction.

- 4. Amendment to Section 5.37.2 Specific Terms

 These changes would add supporting definitions to the amendments summarized above.
- An Ordinance to Amend Sections 7:651 and 7:654 of Chapter 97 (Short-Term Rentals) of Title VII of the Code of the City of Ann Arbor (ORD-21-13). In September of 2020, the City enacted Chapter 97 of the City Code which established requirements for the operation, location, and licensing of short-term rentals in the City of Ann Arbor. Included in the adopted Ordinance are provisions that prohibit the operation of short-term rentals by in residential zoning districts when the location is not the principal residence of the property owner. In December of 2020, the City Council instructed the City Administrator and Planning Commission, if applicable, to develop and proposed amendments to Chapter 97 Short Term Rentals and/or Chapter 55 Unified Development Code, to create a regulatory structure that would enable the continued operation of pre-existing short-term rentals that do not meet the current requirements of Chapter 97. These presented amendments are proposed in

concert with proposed amendments to Chapter 55 – Unified Development Code presented concurrently. The combination of both Ordinances would achieve a prospective enactment of location restrictions for non-Principal Residence Short Term Rentals.

 An Ordinance to Amend Section 2:69 of Chapter 29 (Stormwater Rates) of Title II of the Code of the City of Ann Arbor. This would amend the ordinance to increase stormwater fees for upcoming operating and capital needs consistent with the City's Stormwater Utility Rate Study, Capital Improvement Plan, and Stormwater Asset Management Plan.

Ordinances - First Readings (1)

 An Ordinance to add a Temporary Emergency Ordinance Section 1.327b (Third-Party Delivery Services to Title 1 of Chapter 15 (Emergency and Disaster Management) of the Code of the City of Ann Arbor. This proposed ordinance temporarily caps delivery fees during the COVID-19 pandemic and prohibits third-party delivery services from publishing inaccurate or misleading restaurant menus.

Other

May Water Quality Matters. The May issue of Quality Water Matters encourages residents to celebrate national Drinking Water Week May 2-8 by attending a virtual Water Treatment Plant tour. Those interested can <u>sign up</u> for a 45-minute tour to learn about how the city treats and delivers drinking water to more than 125,000 customers. Free Wood Chips Available. City of Ann Arbor Public Works Department is making free wood chips available to residents at five locations around the city beginning Thursday, April 22, 2021. Residents are required to load and haul the material away themselves. The wood chips will be available while supplies last.

New Dog Licensing Ordinance Now in Effect. At the April 5, 2021, meeting, Ann Arbor City Council approved changes to the city's dog licensing ordinance with the hopes of simplifying the process and compelling more residents to comply with the law. The ordinance now has dog

licenses expiring at the end of the month in which the dog's rabies vaccination expires, with oneand three-year options.

Licensing fees have not changed. The fee to license a spayed or neutered dog remains at \$6 for one year, \$12 for unaltered dogs; and a three-year license is \$15 for spayed or neutered dogs, \$30 for unaltered dogs. Service dogs are licensed for free. Note in accordance with State Law, two-year licenses are no longer available.

Regardless of the month/date when the license is issued, in order to coincide with the effective dates of the rabies vaccinations, dogs having less than 24 months until their next rabies shot will be issued one-year licenses that expire on the last day of the month in which the shot must be administered. For dogs that have 24-months until their next rabies vaccination, a three-year option is available that will expire on the last day of the month of when their next rabies vaccine is due.

The city has issued approximately 3,300 dog licenses. With the changes to the ordinance and increased education efforts, the city aims to reach a licensing compliance rate of 40 percent in the coming years.

Why license? Michigan law requires all dogs over the age of 6 months to be licensed. Licensing protects community health and safety by requiring that rabies vaccinations are administered regularly. In addition, a dog license can help reunite lost dogs with their owners. What's more, only licensed dogs are permitted to play at the city's three off-leash dog parks, Broadway, Olson and Swift Run (www.a2gov.org/dogparks).

Did you know the City of Ann Arbor has a dog leash law? Per Chapter 107 of the city code, it is a violation to have a dog off leash in city parks, other than in a designated dog play area. The violation is punishable, per Chapter 107, 9:52, by a fine of not less than \$25 nor more than \$500 for a first offense and for a second offense not less than \$50 nor more than \$500.

AAPD is Accepting Applications for Police Chaplains Program. Applications are now being accepted for the Ann Arbor Police Department Police Chaplains Program. This program will help the city provide a more comprehensive response to those in need, through support to both civilians and officers alike and during times of crisis and non-crisis incidents.

Ann Arbor Shares List of Planned 2021 Road, Sidewalk, Utility and Resurfacing Projects. The City of Ann Arbor released its list of road and sidewalk projects scheduled for construction in 2021. This year's projects include resurfacing/restoration of nearly 9 miles of roads, 6.2 miles of preventative maintenance and 5,700 feet of new sidewalk construction. All projects are listed online at www.a2gov.org/roadconstruction. Projects and schedules are subject to change. Construction work will cause road and lane closures, so travelers are advised to sign up for email or text alerts, at www.a2gov.org/roads.

May Events with NAP. The community is invited to participate with Ann Arbor Natural Area Preservation in the parks and nature areas this May. Events and volunteer opportunities include stewardship workdays to celebrate Arbor Day, International Migratory Bird Day and Huron River Day (all month long!), as well as the butterfly survey kickoff and much more. 17-year Cicadas. Ann Arbor, along with large parts of the Midwest and eastern United States, will experience a 17-year cicada emergence in May and June 2021. The cicadas, which do not bite and are harmless to humans, will present challenges to smaller saplings while benefiting larger and established trees. In response, the City of Ann Arbor is suspending its spring tree planting efforts and has established a website, www.a2gov.org/cicada (www.a2gov.org/departments/forestry/Pages/17-Year-Cicada-Emergence-.aspx), to help the community understand and prepare for the event.
