All terms, conditions, and provisions of the original agreement between the parties that was effective March 26, 2016, as amended by the First Amendment executed December 21, 2016, Second Amendment executed April 21, 2017, Third Amendment executed June 25, 2018, Fourth Amendment executed December 23, 2019, Fifth Amendment executed May 26, 2020, Sixth Amendment executed February 2, 2021, unless specifically amended above, are to apply to this amendment and are made a part of this amendment as though expressly rewritten, incorporated, and included herein.

This amendment to the agreement between the parties shall be binding on the heirs, successors and assigns of the parties.

In addition, for expert witnesses retained by the Firm, the City shall be responsible for up to Twenty-Seven Thousand Five Hundred Dollars and 00/100 Cents (\$27,500.00) as its share of those expert witness costs.

Including the amount for expert witness services, the total amount for the Services shall not exceed Eight Hundred Thousand Twenty-Five Hundred Dollars and 00/100 Cents (\$825,000.00).
