# Professor Michael Steinberg on Racially Restrictive Covenants in Ann Arbor's Housing History

Professor Michael J. Steinberg Director of the Civil Rights Litigation Initiative at the University of Michigan Law School gave a presentation on the history of racially restrictive covenants in Ann Arbor. Followed by a questions and answer session.

#### **News Notes**

#### Fair Chance (Poster, Complaint Form, Activity)

L. Stambaugh reported that the Fair Chance Access to Housing Ordinance was passed by Council and went into effect on April 18, 2021. Communications is still working on the poster. When ready, the poster will be available to download from City website and HRC website, and included in the City's Tenants' Rights Book. The HRC website has been updated to include information about the new ordinance and IT is in the process of creating the new complaint form.

#### Strategic Planning

L. Stambaugh discussed strategic planning survey results and asked commissioners to rank the project they would like to see done. She will work with commissioners to find a date to schedule the strategic planning meeting.

#### **Town Hall Meeting Plans**

L. Stambaugh gave an update on the community-hosted town hall meeting in Ann Arbor on AAPI hate. L. Stambaugh and A. Sova talked about the fear in the Asian community and how residents want to know how to notify local government when hateful (whether or not criminal) incidents occur.

#### **OLD BUSINESS**

#### Conversion Therapy Proposed Ordinance: Status

L. Stambaugh and L. Winker discussed the changes made to the Prohibition of Conversion Therapy on Minors Ordinance, in response to feedback received from The Trevor Project, The Human Rights Campaign, the National Center for Lesbian Rights, UM Professor Gary Harper, and others, and in consultation with Margaret Radabaugh and John Reiser of the City Attorney's Office. The ordinance was passed on a unanimous vote and will be sent to City Council.

#### 21-1055 Conversion Therapy Ordinance

#### **Conversion Therapy Resolution (revised)**

The resolution in support of the Prohibition of Conversion Therapy on Minors Ordinance passed with changes on unanimous vote and will be sent to City Council.

**21-1088** Resolution to Ban the Use of Conversion Therapy on Minors

#### Resolution in Support of Heightened Sensitivity to the Impact of Speech on Others

*K.* Cowan and A. Sova will bring suggested changes to the resolution to the commission in June.

#### **Crown Amendment**

CM T. Radina discussed the addition of Crown protections (protections against discrimination on the basis of hair texture and hair styles) to the Non-Discrimination Ordinance. The HRC moved to enthusiastically approve the addition of the Crown language to the Non-Discrimination Ordinance. Passed unanimously.
