Councilmember Griswold thanked all of the volunteers who helped make Juneteenth a success.

Councilmember Griswold noted that Caucus is taking a summer break. She stated they are looking at other ways to engage the community.

COUNCILMEMBER HAYNER

Councilmember Hayner asked for a moment of silence regarding the anniversary of the killing of William Lesko by the police.

COUNCILMEMBER SONG

Councilmember Song spoke about race-based violence and said Black/Asian relations are strained. She said both communities are working to repair the relationship.

COUNCILMEMBER GRAND

Councilmember Grand thanked CAN and the Ann Arbor Housing Commission for the opening of the Creekside Court Community Center.

ADJOURNMENT
