Treasurer Charter reported that she approved three invoices totaling about \$384,000.

#### VIII. REPORTS FROM SERVICE PROVIDERS

Bill Mayer said SPARK launched a new event based out of SPARK East called Starting Your Own Business Series which has been rebranded as ACE, Accelerating Company Excellence. This is a program that is very inclusive of small businesses and other non-tech entities. The first session was held August 17, 2021 with 77 registrations.

Two startups had a significant capital raise in August 2021. The company Blue Mayra, which is a network security company, raised \$10M in August. A year ago, they raised 2.6M. SPARK deployed \$837,850 in grant support to them. The second company, NAV Systems raised 2.55M in a series with Arboretum and Narrow Gauge. SPARK used \$20,000 in LDFA funds in support of this company.

In the month of July, SPARK had 24 new business ideas submission forms come in that ended up being 24 new startup companies in one month.
