I move that In the case of BBA22-2004, the appeal of the building official's decision that the work performed at 727 East Kingsley is granted relief from Section 1011.5.2 and the Building Board of Appeals reverses the Building Official's decision that:

3) The applicant has proposed an equal form of construction to suit field constraints and further that the new stair is a replacement of an irregular and non-conforming condition from 1986 that risers and treads were made consistent throughout the stair. That safety non-slip nosings of contrasting of color were added. That the riser height was reduced to meet the new code and that the tread was modified to suit existing constraints and come as close as feasible to current code.
