A. Meter Replacement Updates

94 % of meters have been replaced. There are 1,578 meters that still require replacement.

- B. Service Line Inventory & Replacement Updates
  - 23% of known galvanized lines have been replaced.
  - Sampling for verification 379 locations have been selected.
- C. Progress on WTP Lead Sampling
  - Samples have been submitted and the results are with EGLE.

- Lead action levels change January 1, 2025. Currently at 15 parts per billion, will be 12 ppb after 1/1/25. Those communities that have levels between 12-15 ppb will be in violation.
