## **CALL TO ORDER**

Mayor Hieftje called the meeting to order at 7:10 p.m. in the Washtenaw County Board of Commissioners Room, 220 N. Main St.

#### **MOMENT OF SILENCE**

Council stood for a moment of silence.

#### APPROVAL OF AGENDA

A motion was made by Councilmember Derezinski, seconded by Councilmember Hohnke, that the Agenda be approved as presented. On a voice vote, the Mayor declared the motion carried.

- 1. Tony Keene Medical Marijuana (C-1)

Tony Keene, 240 Crest, expressed concern with the proposed Marijuana Ordinance as it relates to dispensaries. He urged Council to think about the definition of a dispensary and reword the ordinance.

## 2. Dennis Hayes - Medical Marijuana (C-1)

Dennis Hayes, 120 N. Fourth Ave., asked that Council defer approval of the proposed marijuana ordinance at first reading. He suggested Council organize a committee in order to obtain public input regarding the ordinance prior to any further action.

## 3. Robin Schneider - Medical Marijuana (C-1)

Robin Schneider, 2010 E. Michigan Ave., Lansing, Ml., a medical marijuana advocate in the City of Lansing, expressed concerns with the home occupation portion of the ordinance. She felt that creating a named list of distributors would be a direct violation of the State law.

## 4. Rhory Gould - Temporary Moratorium (C-1)

Rhory Gould, 5537 Overbrook, expressed concern with the proposed Medical Marijuana Ordinance in its current written form.

## 5. Charmie Gholson - Medical Marijuana (C-1)

Charmie Gholson, 2729 Cumberland, spoke in opposition to the proposed Medical Marijuana Ordinance.

#### 6. Matthew Abel - Medical Marijuana (C-1)

Matthew Abel, 2930 E. Jefferson, addressed Council regarding the proposed Medical Marijuana Ordinance. He said that limiting dispensary licenses to 15 is unnecessary. He expressed concern about a proposed requirement for landlords to consent in writing to dispensary operations in their buildings, due to the exposure to liability through forfeiture.

## 7. Rick Thompson - Medical Marijuana (C-1)

Rick Thompson, 8092 Sterling, Centerline, MI, editor of Michigan Medical Marijuana Magazine, spoke in opposition to the proposed Medical Marijuana Ordinance as currently written. He asked that the portion of the ordinance regarding the caregiver registration and inspections be stricken from the ordinance.

## 8. Chuck Ream - Medical Marijuana (C-1)

Chuck Ream, 1911 Packard St., spoke in opposition to the proposed Medical Marijuana Ordinance as currently drafted, due to the additional restrictions proposed that are not required under the current State law.

#### 9. Brandy Zink - Medical Marijuana (C-1)

Brandy Zink, 2930 E. Jefferson, Detroit, MI, said that the proposed ordinance is in violation of the Michigan Medical Marijuana Act. She asked that Council consider other sources of information regarding medical marijuana besides the Michigan Municipal League and the DEA. She urged Council to discuss medical marijuana licensing with other cities who have successfully implemented ordinances.

## 10. Henry Herskovitz - Palestine

Henry Herskovitz, 404 Mark Hannah Pl., addressed Council regarding Palestine.

#### **COMMUNICATIONS FROM COUNCIL**

#### COUNCILMEMBER BRIERE

Councilmember Briere asked if a Council Work Session had been scheduled to discuss the proposed Fuller Road Station.

City Administrator Roger Fraser replied that Fuller Station would be discussed at the January 10, 2011 Work Session.

#### COUNCILMEMBER TAYLOR

Councilmember Taylor updated the public on the progress of the Mutually Beneficial Committee. The committee separated the parcel by parcel process and the parking amendment process. The DDA would be looking at the parcel by parcel process on June 5, 2011 and a resolution would also come before Council on January 18.

#### COMMUNICATIONS FROM THE CITY ADMINISTRATOR

#### TRASH PICK-UP

City Administrator Roger Fraser said that the City would observe the Martin Luther King Jr., Holiday on January 17, 2011, and that trash pickup and recycling services would resume as normal that week.

#### AATA UPDATE

The Ann Arbor Transportation Authority Board (AATA) will hold a series of public meetings on February 1, 2011, in the Downtown District Library from 6-8 p.m., to discuss the Moving You Forward County Wide Transit Planning Process.

#### HAZARDOUS MATERIAL INCIDENT

Mr. Fraser announced that the City received a call of a mercury spill at a residence in Ann Arbor. The mercury came from one of two grandfather clocks located in the residence. The clock fell and broke spilling mercury in the home. The spill was cleaned up without incident with the help of the Fire Department and the US EPA National Response Center.

Mr. Fraser explained that if residents have a mercury spill in their home, they should call 911 for assistance. The mercury can emit hazardous vapors so residents should evacuate while they wait for emergency responders.

#### POLICE/COURT BUILDING

Mr. Fraser said that most of the Police operations have been relocated to the new Justice Center building and that the remainder of the 15th District Court operations are being relocated to the new facility by the end of January 2011.

The east side of the 2nd floor of the Larcom Building is closed due to the abatement of asbestos in the ceiling. Staff will continue to have access to the 2nd floor via the back elevators for storage and vending purposes. The Clerk's Office, Council Chamber and workroom, and public bathrooms will not be available to the public or staff during the asbestos abatement on the 2nd floor beginning January 7, 2011.

CITY'S ANNUAL AUDIT STATEMENT

The City's Annual Audit Statement was submitted to the State last week and is now available for viewing online.

#### COUNCIL MAILBOXES

Mr. Fraser informed City Council that their mailboxes have been moved to the 3rd floor during the 2nd floor asbestos abatement project.

#### NEW DIRECTOR OF PENSION SYSTEM

Mr. Fraser announced that Nancy Walker has accepted the Pension Director position with the City. Ms. Walker started her new position on January 3, 2011.

#### EARLY RETIREMENT FEDERAL DRUG SUBSIDY

Administrator Fraser reported that Human Resources recently applied for an Early Retirement Drug Subsidy. The Federal Government provides assistance to local governments who have early retirement programs and experience the increased cost of employee health care as a consequence. The City received a reimbursement check in excess of \$289,000.00 for that purpose from the Federal Government.

#### WORK SESSION

A work session has been scheduled for January 8, 2011 for a follow-up discussion from the Council retreat in December 2010 regarding city service delivery. Mr. Fraser asked that Council submit their ranking of city services by the end of the night so that staff has time to review and rank the results. The meeting will take place at the Wheeler Center beginning at 8 a.m.

6:415., Subsection 4, Substitute with the following:

(4) THE FIRST YEAR'S LICENSES SHALL BE CAPPED AT A NUMBER 10% HIGHER THAN THE LICENSES APPLIED FOR IN THE FIRST 60 DAYS BUT NOT MORE THAN 20 DISPENSARIES AND 10 CULTIVATION FACILITIES LICENSES. ANY LICENSE TERMINATED DURING THE LICENSE YEAR RETURNS TO THE CITY FOR REINSURANCE.

It was considered friendly to remove the following sentence:

DERIVE FROM RECOMMENDATIONS FROM THIS COMMITTEE AND BE MADE
TO CITY COUNCIL FOR THEIR APPROVAL."

Replace Section 2 with a new Section 2 (last page) that reads:

Section 2. THE MEDICAL MARIJUANA LICENSING BOARD SHALL REVIEW THE OPERATION OF THE PROVISIONS OF THIS SECTION AND RECOMMEND CHANGES, IF ANY, TO CITY COUNCIL THAT THE BOARD DEEMS APPROPRIATE ON OR BEFORE JANUARY 31, 2012, OR SUCH OTHER DATE AS COUNCIL MAY SET BY RESOLUTION.

THE MICHIGAN MEDICAL MARIHUANA ACT ACKNOWLEDGES THAT "ALTHOUGH FEDERAL LAW CURRENTLY PROHIBITS ANY USE OF MARIHUANA EXCEPT UNDER VERY LIMITED CIRCUMSTANCES, STATES ARE NOT REQUIRED TO ENFORCE FEDERAL LAW OR PROSECUTE PEOPLE FOR ENGAGING IN ACTIVITIES PROHIBITED BY FEDERAL LAW. THE LAWS OF ALASKA, CALIFORNIA, COLORADO, HAWAII, MAINE, MONTANA, NEVADA, NEW MEXICO, OREGON, VERMONT, RHODE ISLAND, AND WASHINGTON DO NOT PENALIZE THE MEDICAL USE AND CULTIVATION OF MARIHUANA. MICHIGAN JOINS IN THIS EFFORT FOR THE HEALTH AND WELFARE OF ITS CITIZENS." SEE, MCL 333.26422(C). IF YOU HAVE ANY QUESTIONS OR CONCERNS PLEASE CONSULT WITH YOUR ATTORNEY.
