#### CALL TO ORDER

Mayor Hieftje called the meeting to order at 7:10 p.m. in the Guy C. Larcom, Jr. Building, 2nd Floor Council Chambers, 301 E. Huron St.

1. Tom Partridge - Recall Governor Snyder. Protect Michigan's most vulnerable. Provide access to effective law enforcement, public transportation and affordable housing. (DB-2, DS-3, DC-2)

Tom Partridge, Ann Arbor resident, addressed Council urging the recall of Governor Snyder, protection of Michigan's most vulnerable people, providing access to effective law enforcement, public transportation and affordable housing.

### 2. Robert O'Neal - Public Art (C-2)

Robert O'Neal, 501 Onondaga, spoke in support of the existing public art projects in the City. He said that he hoped that Council would not pull back support of the arts at a time when the community could use the boost that public art can provide.

### 3. Atul Nanda - Recycle Bank (DS-2)

Atul Nanda, 911 Golflinks Rd., Ancaster, Ontario, Vice President of Recycle Bank, spoke in support of the City's contract with Recycle Bank and the value of the program to the City. He said that Ann Arbor residents ordered more than 2400 awards last month, the highest number of awards in any given month since the inception of the program last September.

#### 4. Connie Brown - Public Art Program

Connie Brown, 208 Pineridge, spoke in support of the existing public art program. She said that studies have shown art is an important driver in healthy economies. Public art attracts visitors to cities and ensures art is available to all. Ms. Brown urged Council to preserve the arts program as it is because it is important to Ann Arbor.

#### 5. John Kotarski - Public Art (C-2)

John Kotarski, 1230 Saunders Crescent, spoke in support of public art in Ann Arbor. Public art creates a sense of place and identity and makes good business sense, he stated.

## 6. Margaret Parker - Public Art (C-2)

Margaret Parker, 2972 Parkridge, the previous chair of the Ann Arbor Public Art Commission, spoke in support of the City's public art program and the City Hall art project. She spoke in opposition to any changes to the existing ordinance.

## 7. Mark Tucker - Public Art (C-2)

Mark Tucker, 1716 Shadford, co-founder of the Festifools event, spoke in support of the City's public art program. He said that the decision to create a Percent for Public Art Program in Ann Arbor was made by forward-thinking individuals in the community who understood the rewards of investing in a public art program.

## 8. Dori Edwards - Clark Rezoning (C-1)

Doris Edwards, 2904 Maplewood, spoke in support of the rezoning ordinance for Tree City Health Collective. Tree City Collective occupies the entire building at 712 S. State St. and has been in business for over a year without any problems with their neighbors, she stated.

### 9. Jill McGinn - Public Art (C-2)

Jill McGinn, 1715 Glastonbury, spoke in support of the small percentage of money spent on public projects being earmarked for public art. Public art is the art that our children have the most access to, she stated. It gives a sense of place and

personality to Ann Arbor, and improves the community's quality of life.

## 10. Kermit Schlansker - Poverty

Kermit Schlansker, 2960 Marshall, addressed Council regarding poverty. He said that the affluence of American life will diminish through time as raw materials become scarce. Poor people will be faced with a jobless future in which the government is unable to take care of them. He said that we must find solutions for feeding and housing the poor and job creation is needed.

#### COMMUNICATIONS FROM COUNCIL

#### COUNCILMEMBER DEREZINSKI

Councilmember Derezinski reported on the Ann Arbor Public Art Commission, as the new Council liaison. He said that the commission is dedicated to the arts and reflects the very strongly-held feelings and value of art in this community. Councilmember Derezinski noted that he has only been a member for one month and will have more to report over time.

#### COUNCILMEMBER HIGGINS

Councilmember Higgins reported on the Budget Committee. The committee saw a presentation last week of the new staff project, A2 Open Book. She asked Tom Crawford, CFO, to give an update on the project.

*Mr.* Crawford said that A2 Open Book is accessible from the City's homepage, www.a2gov.org. It's a website that provides citizens with an easy way to look at the City's financial records, including the City checkbook. Using A2 Open Book, residents can look-up the City's revenues and expenditures by fund, as well as financial statements for this year and last year by service area.

#### COUNCILMEMBER KUNSELMAN

Councilmember Kunselman read an email from a constituent regarding the use of dedicated millage funds for public art. He also received a posting by a citizen regarding a court case from the State of Michigan; the City of South Haven vs. Van Buren County Board of Commissioners. Mr. Kunselman said that he does support public art, but does not support using dedicated voter millages for public art when the voters approved this money for other purposes, such as the street repair millage.

MANAGING FALL LEAVES

With the cool temperatures of autumn, it's time to think of ways to manage fall leaves. Ann Arborites can choose to mulch their leaves on-site, set paper bags and compost carts of leaves at the curb for weekly pickup, or take advantage of free bulk leaf drop-off at the City's Compost Center at 4150 Platt Road. Please remember that the City no longer picks up loose leaves that have been raked into the street. Details on fall leaf management options, including the hours of the Compost Center, are provided online at www.a2gov.org/leaves.

SUSTAINABLE ECONOMIC DEVELOPMENT ACADEMY

A City of Ann Arbor team including Paul Krutko (SPARK), Martin Dober (Michigan Economic Development Corporation), Roger Bowser (Zingerman's), Mary Jo Callan (Washtenaw County, Community & Economic Development), Wendy Rampson (City Planning & Development Unit), and Matthew Naud (City Systems Planning Unit) participated with 12 other US cities in the Sustainable Economic Development Academy in Denver last week. The team identified opportunities to help local businesses be more sustainable by providing better access to existing city services, and strategies to link the growth of local food systems to job creation.
