		Ginny Trocchio gave a presentation regarding an overview of Conservation Easements. The presentation covered easement basics, conservation easement appraisals, tax implications, drafting easements, standard easement provisions and monitoring and enforcement. (A copy of the presentation is on file in the City Clerk's Office.) Lastly, Ms. Trocchio noted upcoming discussion topics that included a field trip, Greenbelt Commission Partnerships, long term planning and Joint Greenbelt Advisory Commission and Parks Advisory Commission meeting.
		Commissioner Fike asked if Ms. Trocchio if she was aware of any legal challenges to easements (nationally). Also if there was a fund available representing the interest of conservancy against challenges. Ms. Trocchio responded that she believed that the Land Trust Alliance is establishing such a fund. Ms. Trocchio stated that she has heard of conservation challenges and litigation in other areas. She continued that it is important to foster relationships with the landowners so that the Commission can be involved should the ownership of the land changes.
