Mr. Robert Hart motions that in the matter for the variance hearing for BBA17-001 for 220 South Main Street, Ann Arbor, MI that a variance be granted from the specific provisions of the plumbing code to provide for a gender neutral bathroom arrangement for the facility at 220 South Main Street which includes the following: 1 accessible compartment with 1 water closet and sink, 1 accessible compartment with water closet and no sink, 2 standard compartments each with water closet and 2 general use lavatories outside the compartments, and we find this to be equivalent to the provisions of the Code based on PA230 Sec.125.1515 where by the performance of the particular item or part of the building or structure with respect to which the variance is granted is adequate towards intended use and does not substantially deviate from performance required by the Code of that the particular item or part for the health safety and welfare of the people of the State, and the specific condition justifying the variance is neither so general current nor recurrent in nature as to make an amendment of the Code with respect to the condition reasonably practical or desirable. In that regard, the provisions of this variance are not to be taken as a precedent for future such conditions or applications. Approved Vote: 3-2
