The commission discussed a key response from a community member, who recommended replacing "mandatory" language, to "mandatory upon request", for the ordinance enforcement. K. Westphal recommended that the commission speak with Chris Frost about the language change and how it is presented to City Council.

A. Stroud moved to have the commission move to vote on changing the language in the ordinance to reflect the "mandatory upon request" language, seconded by R. Benedict.

A. Stroud would like to move to withdraw the vote on the language change, seconded by R. Benedict. The ordinance will move forward with the ordinance as it is currently written. K. Westphal will send the

ordinance back to City Council.
