9-a 18-0341

Treecity Health Collective Special Exception Use Permit and Site Plan for City Planning Commission Approval - A request to allow the existing space at 2730 Jackson to be used as a Medical Marijuana Provisioning Center by issuance of a Special Exception Use Permit, with an accompanying site plan that demonstrates no physical development change, in accordance with City requirements. Staff Recommendation: Approval

STAFF REPORT:

City Planner, Jill Thacher, provided the staff report. Thacher highlighted the need for the site landscaping to be installed to match the previously approved site plan as well as the addition of bicycle parking.

#### PUBLIC HEARING:

Alec Riffle, 2730 Jackson Avenue, Ann Arbor, petitioner, stated he was made aware of the landscaping needs and bike parking on the site.

Noting no further speakers, the Secretary declared the public hearing closed.

Moved by Gibb-Randall, seconded by Commissioner Wendy Woods

that the Ann Arbor City Planning Commission, after hearing all interested persons and reviewing all relevant information, including an accompanying site plan, finds the petition substantially meet the standards in Chapter 55 (Zoning Ordinance), Section 5:104 (Special Exceptions) and Section 5:50.1 (Regulations Concerning Medical Use of Marijuana), and therefore approves the 2730 Jackson Special Exception Use for a medical marijuana Provisioning Center. This approval is based on the following findings:

- 1. The proposed use will be consistent with the C2B Business Service District, which provides for commercial activities including retail establishments, offices, and personal services.
- 2. The proposed use will not adversely impact traffic, circulation, or streets and road intersections based on the location. Jackson Avenue provides access to the site, and the proposed use is consistent with other surrounding uses' traffic impact.
- 3. There is an existing site plan approved by City Council in 1985 and administratively amended in 1986 on file in Planning Services.
- 4. Through documentation submitted by the petitioner regarding waste disposal, inventory tracking, security, and other methods of operation of the facility, the provisioning center will be operated in a manner that will not have an adverse impact on the neighboring properties or area, and will not have a detrimental impact on natural features.

This Special Exception Use approval is based on the following conditions:

- 1. The petitioner obtaining and maintain both a State of Michigan Medical Marijuana License and a City of Ann Arbor Medical Marijuana Permit, and providing documentation to Planning Services within three years of the City Planning Commission approval date of this petition.
- 2. The petitioner operating a medical marijuana business at this address within three years of the City Planning Commission approval date of this petition.
- 3. The petitioner planting trees shown on the City Council approved site plan that are missing or in poor health, by May 30,

2018. These trees will be of a caliper and species that match the ones shown on the site plan, or equivalent trees of a more appropriate species, as determined by City Staff.

4. The petitioner installing nine bicycle parking spaces as shown on sheet A101.

And that the Ann Arbor Planning Commission approves the attached Site Plan which demonstrates compliance with the applicable Special Exception Use standards as no physical development of the property is proposed.

Arbor Wellness Special Exception Use Permit and Site Plan for City Planning Commission Approval - A request to allow the existing space at 321 East Liberty to be used as a Medical Marijuana Provisioning Center by issuance of a Special Exception Use Permit, with an accompanying site plan that demonstrates no physical development change, in accordance with City requirements. Staff Recommendation: Approval STAFF REPORT:

Jill Thacher provided the staff report, explaining that the current parking provided is gravel; however, no parking is required because it is located in the special downtown parking district. She explained that this business has been in this location for six years and is a well maintained site and the building is a nice presence on the block.

#### **PUBLIC HEARING:**

Jonah Copi, Briarcrest Drive, Ann Arbor, thanked the Planning Commission for all their work, and highlighted the ramp installation on site, as well as other site maintenance performed. He adding that this building has been in their family since 1978. He stated he was happy to be in downtown Ann Arbor, noting that the challenges facing medical marijuana are similar to other businesses.

Noting no further speakers, the Secretary declared the public hearing closed.

#### COMMISSION DISCUSSION:

Moved by Commissioner Julie Weatherbee, seconded by Zach Ackerman, that the Ann Arbor City Planning Commission, after hearing all interested persons and reviewing all relevant information, including an accompanying site plan finds the petition substantially meet the standards in Chapter 55 (Zoning Ordinance), Section 5:104 (Special Exceptions) and Section 5:50.1 (Regulations Concerning Medical Use of Marijuana), and therefore approves the 321 East Liberty Special Exception Use for a medical marijuana Provisioning Center. This approval is based on the following findings:

1. The proposed use will be consistent with the D1 Downtown Core

Zoning District, which encourages a diversity of uses, designed to be accessed by a variety of modes of transportation.

- 2. The proposed use will not adversely impact traffic, circulation, or streets and road intersections based on the downtown location, proximity to transit service, and adequate pedestrian facility access.
- 3. Through documentation submitted by the petitioner regarding waste disposal, inventory tracking, security, and other methods of operation of the facility, the provisioning center will be operated in a manner that will not have adverse impact to the neighboring properties, area, and will not have a detrimental impact on natural features.
- 4. The building occupies an FAR of 64% and some limited open space (none required) in compliance with requirements of the D1 Zoning District.

This Special Exception Use approval is based on the following conditions:

- 1. The petitioner obtaining and maintaining both a State of Michigan Medical Marijuana License and a City of Ann Arbor Medical Marijuana Permit, and provide documentation to Planning Services within three years of the City Planning Commission approval date of this petition.
- 2. The petitioner operating a medical marijuana business at this address, within three years of the City Planning Commission approval date of this petition.

And that the Ann Arbor Planning Commission approves the attached Site Plan which demonstrates compliance with the applicable Special Exception Use standards as no physical development of the property is proposed.

#### 10-a 18-0343

2900 Huron Parkway Landscape Modification for City Planning Commission Approval - The petitioner is proposing a 7,200 square foot addition that will connect the two existing buildings on-site in two locations. Parking spaces will be converted to a landscaped courtyard that results in no net increase in impervious surface. The number of parking spaces is proposed to be reduced by 18. Staff Recommendation: Approval *PUBLIC HEARING:* 

Emily McKinnon, Smithgroup JJR Representing Small building addition, explained that there will be a net decrease in impervious area with the proposed project. She said they believe they are meeting the intent of the Landscape Modification Request through their proposal. She further explained that in order to accommodate bio-retention on site, there would need to be a re-grading of all parking areas.

Noting no further speakers, the Secretary declared the public hearing closed.

Moved by Commissioner Wendy Woods, seconded by Commissioner Zach Ackerman, that the Ann Arbor City Planning Commission hereby approves the proposed landscape modifications according to Chapter 62 (Landscape and Screening Ordinance), Section 5:602 (1)(g).

Gibb-Randall asked the petitioner if they had explored adding a bio-retention areas to the courtyard; she encourage them to incorporate bio-retention into the courtyard at least as a demonstration.

Weatherbee expressed recognition that a property owner is proactively removing parking in favor of greenspace and she appreciates the connection to improve safety.
