J. Landefeld, introduced the the Give 365 and Adopt-a-Park Programs and E. Pratt.

E. Pratt presented an update and shared highlights of the program. Some of the key points of her presentation were:

- 110 parks are served
- 135 days in 2017 were Park/Facility Maintenance and Beautification related
- there are 40 active park adopters out of the 93 adoptable areas
- volunteer hours continue to increase each year
- many different type of projects took place, such as river cleanups, the Argo mural, and park equipment improvements

P. Ramaswami thanked E. Pratt for the level of community engagement involved in these park related programs. She inquired about how people can sign up to get involved.

Pratt explained that people can get involved by phone, email, online sign-up, and that there is a range of commitment level for volunteers.

Resolution reads as follows:

Whereas, The Park Maintenance and Capital Improvements Millage is the principal funding source for the City's park and recreation capital improvement programs and park repair and restoration programs;

Whereas, The Park Maintenance and Capital Improvements Millage was approved by the voters in 2006 and 2012 for six year durations;

Whereas, The Park Maintenance and Capital Improvements Millage will expire in 2018;

Whereas, It is in the Parks best interest to present a new millage to the voters which supports the objectives of the expiring millage and provides essential resources for the ongoing maintenance and improvement of the parks system; and

RESOLVED, That the Park Advisory Commission recommends that City Council place the renewal of the Park Maintenance and Capital improvements Millage on the November 2018 election ballot; and RESOLVED, That the Park Advisory Commission recommend that City Council reaffirms its intent to administer the Park Maintenance and Capital Improvements Millage as amended and approved by Resolution R-11-186 on May 16, 2011.
