1. Alan Haber - Proclamation recognizing Earth Day (INT-2)

Alan Haber, resident, thanked Council for the Earth Day proclamation. He also encouraged residents to attend a celebration of Earth Day at the Center of the City Park on Easter Sunday.

2. Barry Lonik - Resolution to Approve Participation in the Purchase of a Conservation Easement on the Haas Property (CA-15)

Barry Lonik, representative of Scio Township Conservation program, spoke in support of Item CA-15, the Haas property conservation easement. He encouraged City Council to support the project with the use of Greenbelt funds.

3. Glen Nelson - Resolution to Override Mayor's Veto of R-19-137 (DC-3)

Glenn Nelson, representing Citizens for Mental Health, spoke about the Mayor's veto and the resolution (DC-3) to override the veto. He urged Council to recognize all of the voices on this issue.

4. Elizabeth Brooks - Resolution No. 3 Establishing a Public Hearing for Northside STEAM (DS-1)

Elizabeth Brooks, representing the neighbors of the 1600 block of Traver, spoke in opposition to Resolution No. 3, establishing a public hearing for the Northside STEAM safe routes to school sidewalk special assessment project.

5. Fadwa Ashur - Restructuring the Human Rights Commission

Fadwa Ashur spoke about a need to restructure the City's Human Rights Commission, stating there is not a strong enough voice on the Commission for certain minorities. She urged Council to restructure the Commission and include more minority members.

6. Frank Speek - Spin Scooters (CA-41)

Frank Speek, representing Spin Scooters, urged Council to support CA-41, the resolution to approve a license agreement with Spin for the operation of electric scooters in the City. He stated Spin does not operate until an agreement is reached with a community.

COUNCILMEMBER SMITH

Councilmember Smith stated a meeting of Ward 5 precinct delegates will be held on April 23 at the Westgate Library to discuss issues in the ward, including affordable housing.

COUNCILMEMBER BANNISTER

Councilmember Bannister thanked the public and members of Council who attended Sunday's Caucus meeting. She stated the meetings would continue on the Sunday prior to each Regular Session.

Councilmember Bannister stated a meeting will be held for Ward 1 regarding crosswalk safety and she encouraged residents to continue to use A2FixIt for repair and maintenance needs.

Councilmember Bannister encouraged residents to apply for open seats on the City's Boards and Commissions, noting that vacancies currently exist on the Planning Commission.

Councilmember Bannister thanked Mr. Alan Haber for his leadership regarding Earth Day celebrations.

COUNCILMEMBER GRAND

Councilmember Grand thanked the Ward 3 neighbors who came out to discuss proposed development on Packard Road.

Councilmember Grand highlighted Items CC-1, the proposed appointment to the Greenbelt Advisory Commission, noting the resolution will come back at the next meeting for approval. She also pointed out Item F-6, the report from the Student Advisory Council.

Councilmember Grand stated PAC would look at proposed input for the Center of the City Task Force applications, noting that they hope to have the applications on the web soon.

Councilmember Grand also addressed a public speaker's comments

regarding diversity on the HRC, noting that currently five of eight members identify as a minority and LGTBQ is also represented on the Commission.

Councilmember Hayner also spoke about the PAC meeting and their input on the Center of the City Task Force application process.

He stated Ward 1 residents would also be at PAC tomorrow to speak about the possibility of acquiring the property on Barton Drive that recently burned.
