**E REGULAR BUSINESS**

**E-1** [19-1713](#) DR19-010; 402 E Huron Street A design plan for a 9-story hotel at 402 E Huron. Brick, in two colors, is the predominant exterior material, with a strong metal panel corner. The base of the building is a transparent storefront, including a canopy at the main corner entrance extending along both sides. The building is set back from East Huron Street to provide a pedestrian plaza along that side, and the project is pursuing LEED Gold

certification. A driveway will wrap around the rear of the site to provide vehicle access and valet service.

*The Design Review Board discussed the design plan for the proposed Ann Arbor Campus Hotel at 402 East Huron Street and made the following comments and recommendations:*

- 1. The unit vent mechanical louvers for each of the guest rooms should be integrated into the window/spandrel system rather than the brick portions of the façade.*
- 2. The varied color and material choices appear too busy and could be simplified.*
- 3. The material choices for the east façade treat that side as secondary. Please consider a higher quality material usage.*
- 4. Continue the efforts to screen the vehicle arrival area from the historic district adjacent to the east. Consider incorporating sound screening, buffering and/or absorption as well.*
- 5. Explore and consider providing a distinct visual cue for exiting drivers crossing the sidewalk to exit to East Huron Street.*
- 6. Provide more signage details on revised design plan materials.*
- 7. Provide more depth and detail to the proposed fenestration.*
- 8. Consider some or all of the following suggestions to improve the corner element:*
  - o Eliminate part of the dark horizontal element at the second floor.*
  - o Use lighter material colors.*
  - o Lessen the arbitrary pattern of the vertical panels.*
  - o Strengthen the cornice-level sign board form.*
  - o Note that the details of the pressed metal in-fill panels at the roof level may be lost since they are 95 feet above grade.*
- 9. Consider using brighter, lighter colored, more reflective materials because the north façade will be in shadow most of the time.*
