C-1 Rural Internet Disclaimer

Mr. Long explained the usage of Zoom to conduct the meeting and what would happen in the event of internet outages and the steps the commissioners should take to rejoin a meeting in the event of a failure.

C-2 New GAC Member Introduction

C-3 GAC Vacancies/Officers

Chairperson Fike, informed the Commission that the approval of a new Commissioner is set for Council action at the June 15, 2020 meeting. The Commission has also been conducting outreach in an effort to fill the remaining two vacancies on the Commission. She encourage people to apply.

Chairperson Fike also recognized the contributions to the Commission of former Commissioners Buttrey and Stauffer.

C-4 Recent Closings

Mr. Long noted that since December that the City has closed five projects. The projects have added 433 acres to the conservancy with a fair market value of \$3.3 million dollars. The Greenbelt was able secure these properties for a total outlay of \$971,000.00.

C-5 FY20 ACEP-ALE Submissions

Mr. Long has submitted \$2.2 million dollars worth of for federal funding to help acquire two additional properties totaling 338 acres. This request represent the largest project every considered by the Greenbelt. The Commission should learn the results of the funding request in the next 90 days.

C-6 GAC Letters of Support

Chair Fike, stated that the Commission has recently submitted two letters of support. Once letter of support for the Superior Townships application to the Michigan Natural Resources Trust fund. The commission also provided a letter of support for the Washtenaw County Conservation District's November ballot initiative.

Mr. Long state the Washtenaw Area Restoration ballot initiative would appear on the November ballot. While the Washtenaw County Conservation District's mileage renew will be on the August ballot.

C-7 Public Presentations/Media Coverage

Mr. Long, informed the Commission that he recently presented to the residents of Glacier Hills Retirement Community. He has also been contacted by the City of Chelsea and Lima Township, on presenting to their leadership and residents on the process of establishing a Greenbelt.

C-8 July 9 GAC Meeting Reschedule

Chairperson Fike, informed the Commission that the July meeting has been rescheduled for July 9th as a result of the 4th of July holiday.

C-9 Conservation Easement Violation (added to the agenda)

The City currently participates in the Botsford Conservation Easement. In late April the City was notified of unauthorized tree cutting. [The while the] WHILE THE CITY contributed funding to the project, Scio Township is the primary holder of the easement. As a result of this effort the City Attorneys Office will be coordinating with Scio Township. City Council members are aware of the violation and steps are being taken to address it.
