Interim City Administrator Tom Crawford submitted the following reports for information of Council:

Interim City Administrator Crawford thanked Police Chief Michael Cox for walking with protesters earlier today as residents expressed their frustration over the nationwide issue of police brutality and its disproportionate impact on people of color.

Mr. Crawford also addressed the approval of the Police collective bargaining agreement that was previously included as a staff item (CA-14). He discussed the number of questions raised today about the contract and how it relates to the national discussion on police policies and procedures. It was his belief the contract has many of the best practices incorporated into it. However, it's important to take the time to answer the questions City staff has received in a professional manner, so he wanted to highlight it's been removed from this meeting's agenda and will return at a later date for approval. Staff requests Councilmembers share their questions with this week, so a response can be prepared for the next Council meeting.

Mr. Crawford also discussed the working session scheduled for next Monday June 8th. The materials for this meeting are not ready for discussion, so he requested to cancel that meeting and give Council the time back. (There was consensus to cancel the Work Session.)
