*An owner of a short-term rental urged Council to have staff further review options before voting on this proposal.*

*A local realtor urged Council to postpone action and to consider all sides.*

*Bridget O'Connor, Ward 5, expressed concern that there are racial undertones to the ordinance.*

*A property owner on White Street, urged Council to "grandfather" existing businesses.*

*The owner of 1214 Brooklyn stated property owners will pursue litigation to protect their rights.*

*Katie Dortch, property owner and resident, urged Council to grandfather existing short-term rental properties.*

*Pat Lennon, representing Noah Hoffman, stated the current proposal takes away existing property rights.*

*A Ward 5 resident*

*An attorney representing short-term rental property owners stated the proposed ordinance is illegal.*

*Ruth Niedler spoke in support of short-term rentals, stating owners of these properties have cleaned up previous eye sores.*

*A resident and property owner stated they want to use property for short-term rental and for family, but not for long-term rental leases.*

*A short-term rental owner urged Council to grandfather existing properties.*

*A short-term rental owner*

*A short-term rental owner whose property is also owner occupied stated most current rental property is long-term rental.*
