# **8-A** 20-1969 Resolution to Approve Routing a Paved Portion of the B2B Trail Through Barton Nature Area

City of Ann Arbor Landscape Architect Hillary Hanzel presented the proposed resolution to approve routing a paved portion of the B2B Trail through Barton Nature Area and provided an overview of a public meeting regarding the project.

Councilmember Jeff Hayner inquired about any other plans for the city's involvement in the B2B trail.

Smith answered that the remaining large area of work would be connection over the Huron River near Maiden Lane and Fuller Street.

Commissioner Mike Appel shared a preference for the path to be closer to the fence line and train tracks.

City of Ann Arbor Parks and Recreation Deputy Manager Dave Borneman explained that area was native prairie that NAP wished to preserve.

Moved by Borgsdorf, seconded by Appel to approve the Resolution to Approve Routing a Paved Portion of the B2B Trail Through Barton Nature Area

On a roll call vote, the vote was as follows, the Chair declared the motion approved.

Approved resolution reads as follows:

RESOLUTION TO APPROVE ROUTING A PAVED PORTION OF THE B2B TRAIL THROUGH BARTON NATURE AREA

Whereas, In 2007 the City Council passed resolution R-07-516 that designated the Barton Nature Area as a Preserve;

Whereas, In 2016 the City Council stated that at times there are identified capital improvement needs and projects that are generally acceptable to improve ecological diversity, environmental conditions, water quality, and other community benefits;

Whereas, In 2016 the City Council amended resolution R-07-516 to allow construction in areas designated as Preserves as long as the proposed improvement will improve ecological diversity, environmental condition, or water quality as determined by the Parks Advisory Commission (PAC);

Whereas, Resolution R-07-516 states that "Trail maintenance, trail development, and recreational and educational activities that the Natural Area Preservation program finds do not negatively affect the ecological resources of the Preserve are allowed."

Whereas, The feasibility study has identified a preferred alignment for the paved portion of the B2B trail through Barton Nature Area;

Whereas, The rest of the existing trail network in Barton Nature Area will remain unpaved, natural surface trails.

Whereas, The feasibility study identifies the desire to provide unpaved walking path alternatives across Barton Nature area where practical;

Whereas, Natural Area Preservation staff have reviewed the proposed alignment for the paved B2B trail and generally support it; and

Whereas, The value of a paved, accessible portion of the B2B trail through Barton Nature Area is predicated upon the construction of an accessible pedestrian underpass tunnel connecting Barton Nature Area to the paved accessible B2B trail potion in Bandemer Park.

Resolved, That features in the Barton Nature Area identified for protection by NAP are protected during the course of the project and that NAP is consulted during detailed design and construction;

Resolved, That unpaved walking path alternatives across Barton Nature area are constructed where practical;

Resolved, That construction of a paved portion of the B2B trail through Barton Nature Area would only be constructed if the pedestrian underpass tunnel connecting Barton

Nature Area to Bandemer Park has secured funding for construction;

Resolved, That the layout and location of the paved portion of the B2B trail generally follow the placement as detailed in Exhibit A and any significant deviation from this will require PAC review and approval; and

Resolved, That PAC approve construction of a paved portion of the B2B trail through Barton Nature Area as shown in Exhibit A.

Commissioner Borgsdorf volunteered to participate on the Council of the Commons.
