## **PUBLIC COMMENT - GENERAL (3 MINUTES EACH)**

Zachary Storey, resident, apologized to Councilmember Hayner for his comments directed towards him at a previous meeting. He thanked Council for extending the City Administrator search process.

Henry MacConnel, resident, applauded the Council for passing the mask ordinance. He discussed the need for additional enforcement to help prevent the City from becoming a COVID hotspot.

A resident spoke in favor of hiring Tom Crawford, but also spoke in favor of allowing additional public commentary on the matter.

Luis Vasquez, resident, expressed concern about the special meeting not having public commentary at the beginning of the meeting. He expressed disappointment in the entire City Administrator hiring process, starting with the firing of former City Administrator Howard Lazarus.

Peter Houk, a resident, discussed the hiring process and how the City Administrator serves as a public facing individual, and thanked the Council for slowing the process to allow for additional commentary from City residents.

Michelle Hughes, a resident, thanked Council for providing additional time in the City Administrator search process, and encouraged Council to take a proactive approach moving forward to engage the community.

Anna Foster, a Ward Five resident, thanked Council for their vote to extend the amount of time the public has to participate in the City Administrator search process.

Eric Sturgis, a Ward One resident, thanked Amy Cell for her work on the recruitment process of a new City Administrator. He asked that the City work to engage all sectors of the community and that Council listen to the input of residents.

Joe Spaulding, California resident, discussed the need for equity in the City Administrator search process. He also discussed the University of Michigan students who have been photographed partying and not practicing social distancing.

## COMMUNICATIONS FROM COUNCIL

#### COUNCILMEMBER RAMLAWI

Councilmember Ramlawi discussed comments made by other Council Members regarding the recruitment process and how a single member's comments do not reflect the consensus of the Body. He discussed the fact that Council voting unanimously to extend the process speaks to thoroughness of the process. Councilmember Ramlawi urged residents who take the time to email Council to express thoughts beyond a copy and paste statement.

### COUNCILMEMBER LUMM

Councilmember Lumm made a recommendation to the Council Rules Committee that speakers during public commentary be required to state both their name and address.

#### COUNCILMEMBER GRISWOLD

Councilmembebr Griswold reminded residents that the next regularly scheduled meeting will be held on Tuesday, September 8th as a result of Labor Day. The Caucus meeting will be moved to Sunday, August 30th. The Council Mobility Committee will hold their first meeting on Thursday, September 3rd. She also discussed a plan to bring forward a resolution addressing civility during public commentary.

## COUNCILMEMBER HAYNER

Councilmember Hayner discussed comments that may have been misinterpreted from a prior meeting. He stated his pleasure with the City's purchase of Lurie Terrace. Councilmember Hayner discussed the current wildfires in California and the need for additional work towards climate action. He discussed the need for Council to better adhere to their rules and ensure they are only speaking to the motion on the table.

#### COUNCILMEMBER ACKERMAN

Councilmember Ackerman discussed the human impact from the City's purchase of Lurie Terrace. He also discussed the community conversation surrounding the City Administration hiring process.

## COUNCILMEMBER SMITH

Councilmember Smith discussed the need to maintain civility and respect on Council.

## **ADJOURNMENT**

A motion was made by Councilmember Griswold, seconded by Councilmember Smith, that the meeting adjourn. On a voice vote, the Mayor declared the motion carried and the meeting adjourned at 9:43 p.m.
